A RESOLUTION ACCEPTING THE BID OF PERKINS BUICK-PONTIAC-GMC TRUCK, INC. FOR THE PURCHASE OF TWO UNMARKED POLICE CARS FOR THE CITY OF CENTERVILLE AND TO AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT IN CONNECTION THEREWITH.

WHEREAS, the City advertised for bidders for the purchase of two unmarked police cars for the City of Centerville, pursuant to specifications prepared by the City; and

WHEREAS, Perkins Buick-Pontiac-GMC Truck, Inc. was the lowest and best bidder for the purchase of two Buick Regals at a purchase price of \$28,472.00; and

WHEREAS, the City of Centerville has been informed that all Buick Regal orders have been canceled due to year end part shortages, and


