A RESOLUTION OF INTENT TO APPROPRIATE CERTAIN EASEMENTS FOR THE EAST WHIPP ROAD PROJECT FROM ROBERT SCHAEFFER HAYES ET AL PARCEL 24.

WHEREAS, the City of Centerville is engaged in the acquisition of right of way for the East Whipp Road Project in the City of Centerville, and

WHEREAS, the acquisition of that parcel of real estate is immediately necessary for the roadway construction in connection with said project, and

WHEREAS, the Council has determined that the lands hereinafter described are necessary for roadway construction in connection with such project so that there will be no delay for the immediate preservation of the public peace, health, safety and welfare.

This Council hereby declares the necessity and intention to appropriate certain temporary easements and slope easement in accordance with Chapter 163 of the Ohio Revised Code.

Section 2. It is necessary and intention to appropriate certain easements in the real estate described herein: as more fully described in Exhibit "A' attached and incorporated herein;

Section 3. That the City Nanager or his designate is hereby authorized to cause written notice of the adoption of this Resolution to be given to the owners, persons in possession of, or having an interest of record in the above described premises, and said notice shall be served according to law by a person to be designated for that purpose by said City manager of his designate and to make return of said service of notice in the manner provided by law.
