TACTICAL CRIME SUPPRESSION UNIT EXTENSION AGREEMENT

This Agreement entered into on the _____ day of _____, 1987 by and among THE MIAMI VALLEY CABLE COUNCIL, a regional council of governments organized pursuant to Chapter 167 Ohio Revised Code (Council) and the cities of Centerville, Kettering, Miamisburg, Moraine, Oakwood and West Carrollton, all being Ohio municipal corporations (Municipalities).

WITNESSETH:

Whereas, on November 21, 1985 the parties entered into an Agreement to deal more effectively with the present and projected crime levels in the Municipalities which resulted in an effort entitled the "Tactical Crime Suppression Unit" (TCSU); and

Whereas, said Agreement expired on December 31, 1985 and;

Whereas, the parties hereto wish to extend said Agreement, a copy of which is attached hereto as Exhibit "A" and incorporated herein as if fully rewritten;

Now, therefore, in consideration of the above recitations and the benefits to them mutually accruing the parties hereto agree as follows:

Section 1. That the Agreement attached hereto as Exhibit "A" and incorporated herein as if fully rewritten is hereby extended under the same terms and conditions until midnight, December 31, 1987.

Section 2. This Agreement represents the entire understanding among the parties. No modification or amendment shall be effective unless in writing signed by all parties.

this Agreement or identical copies of same and shall become effective upon the execution by the last of the parties executing the same.
