A RESOLUTION ACCEPTING THE MONTGOMERY COUNTY BUDGET
COMMISSION'S ALTERNATIVE METHOD OF DISTRIBUTING 1988
LOCAL GOVERNMENT FUNDS.

WHEREAS, the Ohio Revised Code, Section 5747.53, authorizes a County Budget Commission to adopt an alternative method of Local Government Fund allocation, with the concurrence of the Board of County Commissioners, the legislative body of the largest city located wholly or partially within the County, and a majority of the boards of townships trustees and legislative boards of the municipalities located wholly or partially within the County; and

WHEREAS, the Montgomery County Budget Commission has proposed an alternative formula for the 1988 Local Government Fund distribution only; and


WHEREAS, the City of Centerville wishes to approve the use of this alternative method for 1988 only;

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:


That we hereby accept and approve the 1988 alternative method proposed by the Montgomery County Budget Commission to wit: The sum of \$179,343 shall be allocated to the Montgomery County Combined Health District. The remainder of the fund shall be allocated to each participant in proportion to the average for the years 1984-1987 of the Local Government Fund allocation as approved for that participant by the Budget Commission (excluding the Health District allocation); and

That the Clerk of this Council is hereby directed to certify a copy of this Resolution to the Montgomery County Auditor.
