A RESOLUTION TO AMEND RESOLUTION 33-85 IN ITS ENTIRETY AND TO AUTHORIZE AND DIRECT THE ALLOCATION OF INCOME TAX RECEIPTS RECEIVED ON AND AFTER JUNE 1, 1986 BETWEEN THE GENERAL FUND, STREET CONSTRUCTION AND MAINTENANCE FUND, DEBT RETIREMENT FUND, CAPITAL IMPROVEMENTS FUND, EQUIPMENT RESERVE FUND, CENTRAL VEHICLE PURCHASE FUND AND GENERAL INSURANCE DEDUCTIBLE TRUST FUND OF THE CITY OF CENTERVILLE.

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

SECTION 1. Resolution 33-85 passed December 16, 1985 is hereby repealed in its entirety and substituted with the following:

SECTION 2. From all Municipal Income Tax receipts received by the City, the following allocation is hereby to be made between the General Fund, Street Construction and Maintenance Fund, Debt Retirement Fund, Capital Improvements Fund, Equipment Reserve Fund, Central Vehicle Purchase Fund, and General Insurance Deductible Trust Fund.

To the General Fund - Sixty-six and two tenths (66.2) percent,

To the Street Construction and Maintenance Fund - Six and six tenths (6.6) percent,

To the Debt Retirement Fund - Seven and eight tenths (7.8) percent,

To the Capital Improvements Fund - Six and eight tenths (6.8) percent,

To the Equipment Reserve Fund - Seven and eight tenths (7.8) percent,

To the Central Vehicle Purchase Fund - Four and four tenths (4.4) percent,

To the General Insurance Deductible Trust Fund - Four tenths (.4) percent.

SECTION 3. The Director of Finance is hereby authorized and directed to take all necessary action in order to carry out the allocations.
