STATE HIGHWAY PATROL RENTAL AGREEMENT

For and in consideration of the monthly payment of <u>Five Hundred and</u> <u>Tventy-Five</u> dollars (\$<u>525.00</u>) to be paid quarterly on the calendar year basis by the Party of the Second Part, the Party of the First Part agrees to rent the following described property to the Ohio State Patrol beginning <u>Tanuary 1, 1990</u> and until such time as this agreement is terminated by mutual consent or the giving of <u>minety (90)</u> days written notice by either Party.

A 50' X 33' (1650 sq. ft.) one story business type building located at 100 V. Spring Valley Road (rear), Centerville, Ohio, which includes two restrooms, medium office area, lounge, small office, and larger testing room with counter space. Building to be sentrally heated and cooled. Grounds to include 20 parking spaces in front of building and large blacktop area to rear of building with entrance and exit availability. Building and grounds to be used for the purpose of giving driver license examinations.

Party of the Second Part to pay all electrical energy, telephone, heating, water and sevage bills and provide junitorial service.

Party of the First Part to assume taxes, assessments, and assume exterior normal building maintenance including heating, cooling, plumbing facilities, roof repair and interior wall damage caused by leaks, maintain driveways and parking and test blacktop areas, so that Party of the Second Part may properly conduct driving tests. No alterations to be made to the building without permission of Party of the First Part.

Party of the Second Part may erect standard Highway Petrol driver license examination signs including traffic control signs as needed, with the consent of the Party of the First Part in accordance with local laws.

Party of the Second Part agrees to abide by any reasonable rules or regulations not inconsistent with good judgment or the operation of giving driver license examinations and upon termination of the agreement to return the premises in substantially as good a condition as commencement of the term, damage from natural elements or those arising from any circumstances beyond the control of the Party of the Second Part excepted.

Invoices to be submitted on a calendar quarterly basis.

It is agreed that this Lease is made subject to appropriation made, or to be made by the legislature of the State of Ohio, State Highway Patrol shall not be liable for payment of rent under this Lease, or and renewal extension thereof, unless or until such appropriation is made, and availability of funds certified pursuant to section 126.07 of the Revised Code.
