
WHEREAS, the City advertised for bidders for a police communication console and base radio for the City of Centerville, pursuant to specifications prepared by the City; and

WHEREAS, Motorola Communications & Electronics was the lowest and best bidder;


NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPALITY OF CENTERVILLE THAT:
