A RESOLUTION AUTHORIZING AND DIRECTING THE CITY MANAGER
TO ENTER INTO A CONTRACT WITH THE MONTGOMERY COUNTY
COMBINED GENERAL HEALTH DISTRICT FOR DAYTON FREE CLINIC
AND COUNSELING SERVICE FOR THE YEAR 1985.

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

SECTION 1. The City Manager is hereby authorized and directed to
enter into a Contract for Dayton Free Clinic and Counseling Service with the
Montgomery County Combined General Health District, a copy of which Contract is
attached hereto, marked Exhibit "A" and incorporated herein, for the year
1985 and to expend the sums therein stipulated.

EXHIBIT 1

A G R E E M E N T

THIS AGREEMENT is made by and between the City of CENTERVILLE, Ohio, (hereinafter CENTERVILLE), and the Board of Health of the Montgomery County, Ohio, Combined General Health District, (hereinafter "Board of Health") under the following circumstances:

WHEREAS, a Board of Health and the legislative authority of a City may contract for the provision of health services pursuant to O.R.C. 3709.281, and

WHEREAS, the Board of Health, the City of Dayton and the United Way are desirous of maintaining a services known as the Dayton Free Clinic and Counseling Service, (hereinafter "Free Clinic") which provides counseling and referral services to youths between the ages of thirteen and nineteen, and

WHEREAS, CENTERVILLE desires to share in the cost of maintaining the Free Clinic.

NOW, THEREFORE, it is agreed between the parties that:

1. The Board of Health hereby agrees to operate and maintain the Free Clinic for so long as the present budget will permit.
2. In consideration of the continued operation and maintenance of the Free Clinic, CENTERVILLE shall pay One Thousand Dollars (\$1,000) as its pro-rated share for the cost of this service.
3. The Board of Health shall periodically submit to CENTERVILLE a statement of services incurred in carrying-out the provisions of this agreement.
4. This Agreement shall be in effect from January 1, 1984 through December 31, 1984. This Agreement may be terminated with six (6) months written notice.
