THIS AGREEMENT is made by and between th	ne City of <u>CENTERVILLE</u> , Ohio,					
(hereinafter <u>CENTERVILLE</u> ), and the B						
Ohio, Combined General Health District, (hereinafter "Board of Health") under the						
following circumstances:						
WHEREAS, a Board of Health and the legis	slative authority of a City may contract					
for the provision of health services pursuant to O.R.C. 3709.281, and						
WHEREAS, the Board of Health, the City of Dayton and the United Way are desirous						
of maintaining a services known as the Dayton Free Clinic and Counseling Service,						
(hereinafter "Free Clinic") which provides counseling and referral services to youths						
between the ages of thirteen and nineteen, and						
WHEREAS, CENTERVILLE desires to share in the cost of maintaining the						
Free Clinic.						
NOW, THEREFORE, it is agreed between the parties that:						
1. The Board of Health hereby agrees to operate and maintain the Free Clinic						
for so long as the present budget will permit.						
2. In consideration of the continued of						
Free Clinic, <u>CFNTERVILLE</u> shall pay <u>One Thousand Dollars (\$1.000)</u>						
as its pro-rated share for the cost of this service.						
3. The Board of Health shall periodically submit to <u>CENTERVILLE</u> a statement of services incurred in carrying-out the provisions of this						
agreement.	rom January 1, 1984 through December 31,					
1984. This Agreement may be terminated with six (6) months written notice.
