A RESOLUTION RATIFYING THE ACTION TAKEN
BY THE CITY MANAGER TO EXECUTE AN
AMENDMENT TO AN AGREEMENT WITH THE CITY
OF KETTERING FOR BUILDING INSPECTION
SERVICES.

WHEREAS, the City of Kettering and the City of Centerville
are desirous of providing assistance to each other with respect
to building inspection services; and


WHEREAS, pursuant to Section 715.02 Ohio Revised Code, said
parties entered into such an agreement on December 13, 1978; and

WHEREAS, the parties now wish to amend said agreement to
allow City of Kettering to make a charge to the City of
Centerville for all inspection services except electrical
inspections;

NOW, THEREFORE, the municipality of Centerville hereby
resolves:

Section 1. That the Council of the City of Centerville,
Ohio, hereby ratifies the action taken by the City Manager to
execute an Agreement, a copy of which is attached hereto,
incorporated herein and marked Exhibit "A", said Agreement with
the City of Kettering to provide assistance on a reciprocity
basis with the City of Centerville with respect to building
inspection services when requested and available and to provide
for the payment of a charge by the City of Centerville for all
such services except for electrical inspection.

AGREEMENT

This Agreement made and entered into by and between the CITY OF CENTERVILLE, OHIO, and the CITY OF KETTERING, OHIO, both being Ohio municipal corporations located in Montgomery County, Ohio.

W I T N E S S E T H:

WHEREAS, on December 13, 1978 the parties entered into an Agreement pursuant to Section 715.02 Ohio Revised Code which Agreement provided that each party would furnish manpower and equipment from its Division of Building Inspection to the other party under the terms and conditions set forth in said Agreement; and

WHEREAS, pursuant to Paragraph 6 of said Agreement, the Agreement can be amended and modified only in writing signed by the duly authorized representatives of the parties; and

WHEREAS, the parties now wish to amend and modify its said Agreement as set forth herein;

NOW, THEREFORE, in consideration of the above recitations and the benefits to them mutually accruing, the parties agree to amend the Agreement of December 13, 1978 as follows:

1. The parties agree that Paragraph 4 of the Agreement of December 13, 1978 shall be amended as follows:

"No charge shall be made to the contracting parties entering into this Agreement for services rendered under the provisions of this Agreement; provided, however, that the City of Kettering may charge the City of Centerville and the City of Centerville agrees to pay the City of Kettering for all inspection services provided for hereunder except electrical inspection at the rate of \$16 per hour."

2. In all other respects, the parties hereby ratify and reinstitute all of the provisions of said Agreement of December 13, 1978.

IN WITNESS WHEREOF, the City of Centerville, Montgomery County, Ohio, and the City of Kettering, Montgomery County, Ohio, have accepted this Agreement, and have authorized its execution in accordance with ordinances or resolutions passed by the respective councils of the cities of Centerville, Ohio and Kettering, Ohio.
