

A RESOLUTION AUTHORIZING THE FIRST NATIONAL BANK, DAYTON, OHIO, TO HONOR ALL CHECKS, DRAFTS OR OTHER ORDERS FOR THE PAYMENT OF MONEY DRAWN BY THE CITY OF CENTERVILLE, OHIO, WHEN BEARING OR PURPORTING TO BEAR FACSIMILE SIGNATURES.

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:


- RESOLVED, that the First National Bank, Dayton, Ohio, be and is hereby requested, authorized and directed to honor all checks, drafts or other orders for the payment of money drawn by the City of Centerville when bearing or purporting to bear the facsimile signatures of any of the following persons, to-wit: William L. Bettcher, alone, and William L. Bettcher and Darryl K. Kenning, together.

And the First National Bank, Dayton, Ohio, (including the correspondent banks) shall be entitled to honor and charge the City of Centerville, for all such checks, drafts or other orders for the payment of money, regardless of, by whom or by what means the actual or purported facsimile signature or signatures thereon may have been affixed thereto, if such facsimile signature or signatures resemble the facsimile specimens from time to time filed with the First National Bank, Dayton, Ohio, by the Clerk of Council or other officers of the City of Centerville, Ohio; and the City of Centerville, Ohio agrees to and will release said bank from liability on account of payment by it of such checks, drafts or other orders for the payment of money, and does hereby agree to save said bank harmless from loss incurred by it as a result thereof; and
