A RESOLUTION ACCEPTING THE BID OF STENGERS FORD, INC.

enter into any necessary Contract to evidence acceptance of said bid and to  
make payment pursuant thereto.

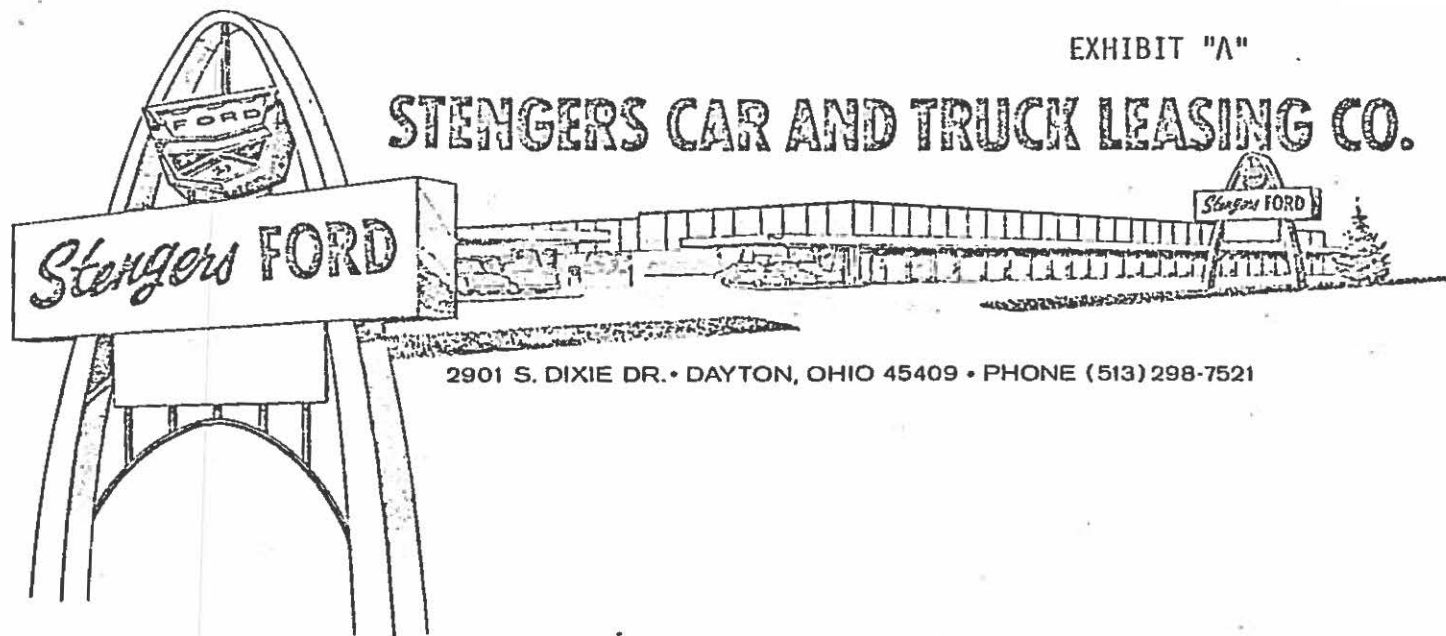

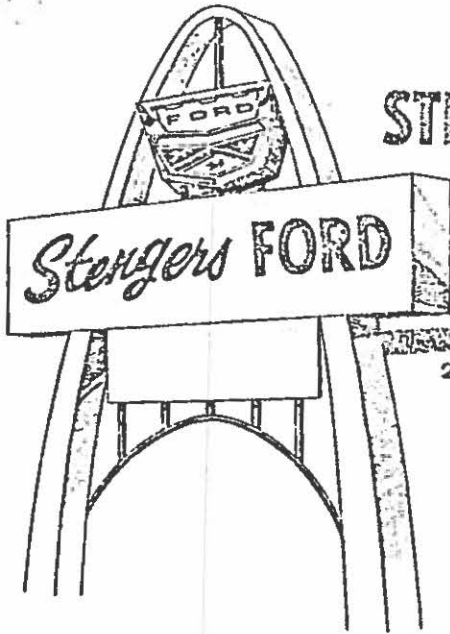
