BOARD OF ARCHITECTURAL REVIEW

APPROVAL OF MINUTES

No additions or corrections were noted for the minutes of the BAR regular meeting of April 2, 2019.

MOTION: Mr. Hoback made a motion to approve the minutes, as distributed. Mr. Holloway seconded the motion. The motion passed 6-0.

OLD BUSINESS

P2019-0010 – CERTIFICATE OF ZONING COMPLIANCE 29 E. FRANKLIN – ACCESSORY STRUCTURE (Tabled at previous meeting)

MOTION: Mr. DeMariano made a motion to remove the item from the table. Mr. Ovington seconded the motion. The motion passed 6-0.

Applicant is requesting to construct a patio cover over an existing outdoor seating area.

Mr. Yandrick presented the case information, including project proposal, photos, staff analysis, standards for approval, status of case since the April 2, 2019 tabling with regard to the adjacent property, and staff recommendation.

Mr. Yandrick advised Staff recommends approval without any conditions.

Mr. Leland Rosato addressed the Committee, representing the applicant as architect for the project. Mr. Rosato explained cost increases, electrical relocation needs, and increased project scope deter the applicant from amending the project as suggested by the BAR at the previous meeting. Mr. Rosato noted the project was designed to complement the existing structure and nature of the community.

MOTION: Mr. DeMariano made a motion to approve the project as presented. Mr. Ovington seconded the motion. The motion passed 6-0.

Mr. Yandrick advised the property at 8661 Dayton Lebanon Pike has been purchased by a developer, but the City has not been approached about or been made aware of any modifications to the Landmark property.

Mr. Yandrick advised Nelly's restaurant is proposing an outside seating area, and this item may come before the BAR at the June meeting.

Mr. Yandrick provided an update on the Planning Department status and the City Planner position.

Mr. Yandrick advised the BAR will have a new committee member beginning in June. Joyce Ray-Brown was appointed by Council on May 6 and will be sworn in on May 20.

Mr. Yandrick provided an update on the APD Visioning Committee.
