
Section 2. The Council of the City of Centerville does hereby expressly waive an irregularity in the receipt of the Bid Bond submitted with this Bid.



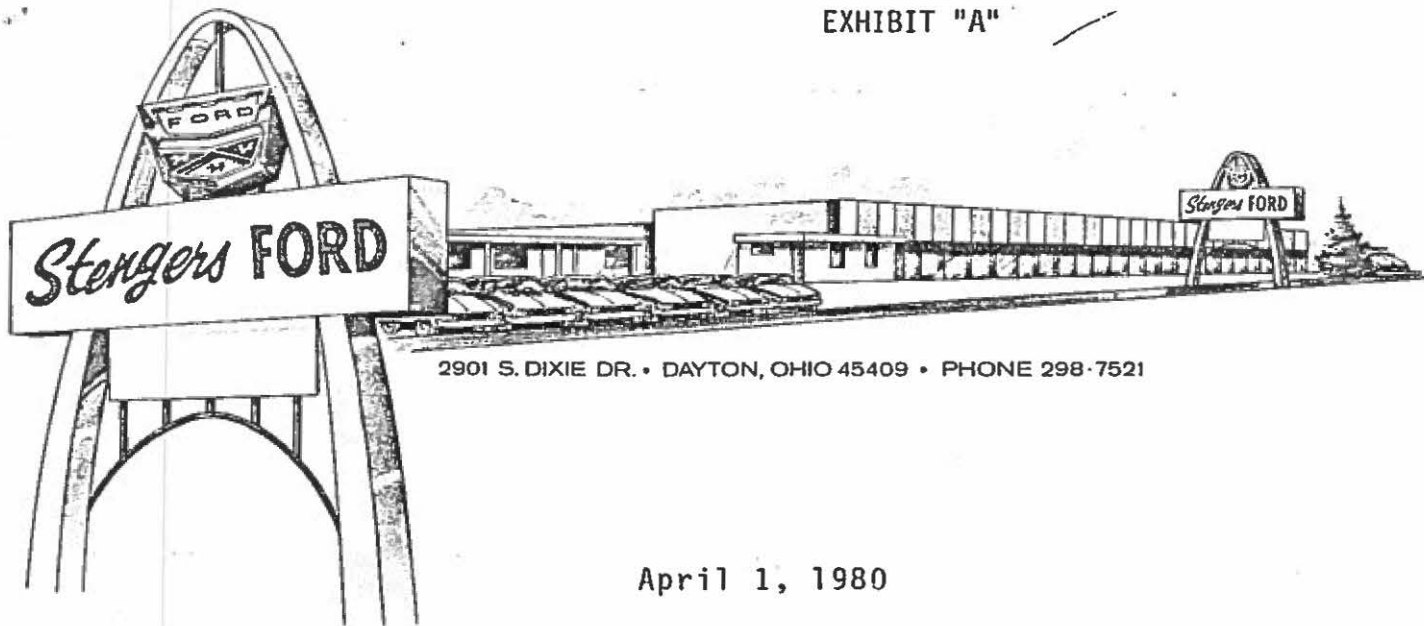
