A RESOLUTION SPECIFYING APRIL 11,1978 AS THE DATE FOR SUBMITTING TO THE ELECTORS OF THE CITY OF CENTERVILLE (MONTGOMERY COUNTY) OHIO FOR THEIR APPROVAL THE LEVYING OF AN ADDITIONAL TAX ON INCOME AT THE RATE OF ONE QUARTER OF ONE PERCENT IN ADDITION TO THE ONE PERCENT CURRENTLY BEING LEVIED AND COLLECTED; LIMITING THE TAX CREDIT GRANTED FOR MUNICIPAL INCOME TAXES PAID TO OTHER MUNICIPALITIES BY RESIDENTS OF CENTERVILLE, OHIO; AND DIRECTING THE BOARD OF ELECTIONS OF MONTGOMERY COUNTY TO CONDUCT THE ELECTION.

Whereas, Ordinance No. 2-72, passed by the City Council of Centerville on the 4 day of Feb., 1978 provides for the levying of a tax on income at the rate of one quarter of one percent in addition to the one percent tax on income currently being levied and collected, and limiting the tax credit granted to residents of Centerville for municipal income taxes paid to other municipalities to the one percent tax currently being levied and collected; and said Ordinance further provides for submitting the levy of said additional one quarter of one percent tax and the limiting of said tax credit to the electors of said City at an election to be on April 11, 1978, said additional tax to begin May 1, 1978; and

Whereas, Section 718.01 of the Revised Code of Ohio requires that such an income tax in excess of one percent shall not be levied without first having been approved by a majority of the electors on the question at a general, primary, or special election; and

Whereas, the Council of the City of Centerville desires that a special election be held in the City of Centerville on April 11,1978 at which time said Ordinance shall be submitted to the electors for their approval as required by the statutory section referred to above; and

Whereas, pursuant to Section 5.08 of the Centerville Charter this Resolution shall become effective immediately upon passage;

NOW THEREFORE,

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That April 11,1978 shall be, and it hereby is, specified as the date of a special election to be held to submit to the electors for their approval Ordinance No. 1-75 levying a tax on income at the rate of one quarter of one percent in addition to the one percent on income currently being levied and collected; limiting the tax credit granted to residents of Centerville for municipal income taxes paid to other municipalities to the one percent tax

currently being levied and collected, said additional tax to begin May 1, 1978.

Section 2. That the Board of Elections of Montgomery County, Ohio shall be, and it hereby is, directed to conduct the special election as specified in Section 1. of this Resolution.

Section 3. That the ballot for said special election specified in Section 1 of this Resolution shall be in the following form:

"Shall the Ordinance providing for an additional one quarter of one percent (1/4%) levy on income beginning May 1, 1978 for the purpose of providing funds for the purposes of general Municipal operations, maintenance, new equipment, extension and enlargement of Municipal services and facilities and capital improvements of the City and limiting the tax credit granted to residents of Centerville for municipal income taxes paid to other municipalities to the one percent (1%) tax currently being levied and collected be passed?"

Section 4. That the Clerk of the City Council shall be, and she hereby is, authorized and directed forthwith to file a certified copy of this Resolution, together with a certified copy of said Ordinance No. 2-72, with the Board of Elections of Montgomery County, Ohio.

Section 5. Pursuant to Section 5.08 of the Centerville Code this Resolution is effective immediately upon passage.
