SPONSORED BY COUNCILMAN Russell Sweetman ON THE 17th
DAY OF July, 1978.

A RESOLUTION DECLARING THE CASE OF REAL AND PRESENT EMERGENCY ARISING IN CONNECTION WITH THE PURCHASE OF GASOLINE AND DIESEL FUEL AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO ENTER INTO A CONTRACT FOR THE PURCHASE OF GASOLINE AND DIESEL FUEL WITHOUT ADVERTISING.

WHEREAS, the Council of the City of Centerville hereby declares the existence of a case of real and present emergency arising in connection with the purchase of gasoline and diesel fuel for the City of Centerville; and


WHEREAS, Sections 735.051 Ohio Revised Code provides that in the case of a real and present emergency Council may, by a two-thirds vote of all members elected, authorize the City Manager to enter into a contract for the purchase of said petroleum products:

NOW, THEREFORE,

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:


Section 1. That the City Manager is hereby authorized and directed to accept the proposal for gasoline and diesel fuel attached hereto marked Exhibit A and incorporated herein without advertisement for said bids due to the FEA allocation regulations which state that unless we mutually terminate our relationship with our current supplier of record or the FEA changes their Mandatory Petroleum Allocation Program, other suppliers cannot bid for our gasoline and diesel fuel needs. These petroleum products are immediately needed by the City of Centerville to provide services and to preserve, protect and promote the public safety of the citizens of Centerville.

Thank you for the opportunity to submit our proposal for your fuel requirements for the next twelve (12) months. We are pleased to submit the following:

Sohio Octron (Regular) Gasoline is \$0.4106 per gallon, delivered in transport quantities of 5000 gallons. Sohio Cetron (Unleaded) Gasoline is \$ 0.4506 per gallon, also delivered in transport quantities of 5000 gallons. Sohio Diesel Supreme is \$ 0.476 per gallon, delivered in tankwagon quantities of less than 5000 gallons.

The above prices are subject to the following conditions:

1. Prices are not firm and are subject to change without notice. However, we shall attempt to notify you promptly at the time of any price changes.
2. The above prices are exclusive of all applicable taxes.
3. Our terms are Net 30 Days from the Date of Delivery.

Our records indicate that we own some of the equipment that you are presently using. You may continue to use this equipment so long as we are the supplier, and we will continue to make minor repairs as necessary. However, in the event that any of this equipment becomes inoperable, and cannot be replaced, it will be necessary for the City to purchase any new equipment.

We have adequate suppliers of both gasoline and diesel fuel that we should have no problems supplying your requirements for the next twelve (12) months.

We have certainly enjoyed the privilege of supplying your requirements down through the past years, and are looking forward to continuing this most pleasant relationship to our mutual advantage.
