A RESOLUTION REPEALING RESOLUTION 31-77; WITHDRAWING THE PETITION TO THE MONTGOMERY COUNTY BOARD OF COUNTY COMMISSIONERS REQUESTING THE ESTABLISHMENT OF A NEW TOWNSHIP, AND AUTHORIZING AND DIRECTING THE CLERK OF COUNCIL TO CERTIFY THIS RESOLUTION TO THE SAID BOARD.

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:


Section 1. That Resolution 31-77, set forth in full hereafter in brackets, is hereby repealed:

[That a petition is hereby authorized and directed to be presented to the Montgomery County Board of County Commissioners requesting that said Board establish a new township with boundaries corresponding to and the same as the corporation limits of the City of Centerville.]

Section 2. That the petition filed with the Montgomery County Board of County Commissioners pursuant to the authority and direction of Resolution 31-77 is hereby withdrawn.


Section 3. That the Clerk of Council is hereby authorized and directed to cause a certified copy of this Resolution to be served upon the said Board of County Commissioners.
