

RESOLUTION NO. 7-76

CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMAN Charles McQuinn ON THE  
2nd DAY OF February, 1976.

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR CONSULTING SERVICES WITH RALPH L. WOOLPERT COMPANY FOR AN AMOUNT NOT TO EXCEED \$60,000.00 PLUS \$35,000.00 FOR SERVICES RENDERED DURING CONSTRUCTION FOR ENGINEERING SERVICES IN CONNECTION WITH THE EXTENSION OF CLYO ROAD FROM ALEXANDERSVILLE-BELLBROOK ROAD NORTH AND EAST TO WILMINGTON PIKE IN THE CITY OF CENTERVILLE.

WHEREAS, the City of Centerville has been petitioned by property owners adjoining a proposed extension of Clyo Road from Alexandersville-Bellbrook Road north and east to Wilmington Pike within the City; and

WHEREAS, in order to initiate the construction of said roadway, it is necessary to secure initial engineering work; and

WHEREAS, the Ralph L. Woolpert Company, consulting engineers and planners, has proposed to do the required engineering work for the City of Centerville for an amount not to exceed \$60,000.00 plus \$35,000.00 for services rendered during construction; and

WHEREAS, professional engineering work is a personal service type contract which is not required to be open to public bidding pursuant to Section 735.05 Ohio Revised Code; and

WHEREAS, the Council of the City of Centerville has determined that the Ralph L. Woolpert Company is competent and able to undertake said engineering work;

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. The City Manager of the City of Centerville is hereby authorized and directed to enter into a contract with the Ralph L. Woolpert Company, a copy of which is attached hereto and incorporated herein, for the necessary engineering work in connection with the extension of Clyo Road from Alexandersville-Bellbrook Road north and east to Wilmington Pike in the City of Centerville for an amount not to exceed \$60,000.00 plus \$35,000.00 for services rendered during construction.
