

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:



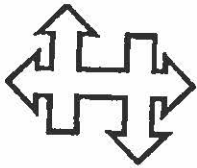

"1976" CONTRACTUAL AGREEMENT  
FOR  
PUBLIC HEALTH SERVICES

To: Mayor and Council  
Centerville

ATTENTION: Mr. Darryl Kenning

By unanimous consent of the Montgomery County Board of Health, the Health District agrees to conduct a public health program and render public health services for the City of Centerville for one year commencing January 1, 1976, equivalent to the program carried on within the Montgomery County General Health District so far as the present budget will permit.

For such services, the City of Centerville agrees to pay to the Montgomery County Board of Health the sum of Twenty-Eight Thousand Five Hundred Twenty-Five (\$28,525) Dollars plus the amount of reimbursement received from the State Treasurer and generally known as State Subsidy to local public health.
