Sohio Diesel Supreme @ \$.381 per Gallon\*

\*Prices shown above are today's prices and are not firm, rather they will be subject to change without notice. We will attempt to notify you promptly at the time of price changes.

The above prices are exclusive of all tax. Terms are Net 30 Days from the date of delivery.

Our records indicate that we own some of the equipment that you are presently using. You may continue to use this equipment so long as we are your supplier, and we will continue to make minor repairs as necessary. However, in the event that any of this equipment becomes inoperable, and cannot be replaced, it will be necessary for the City to purchase any new equipment.

Since all petroleum products are controlled by the Federal Allocation Program, your supply and delivery schedules will be subject to these regulations. We were your base period supplier and will continue to supply your needs according to the allocation program, so long as these rules are in effect. We have adequate supplies of both gasoline and diesel fuel that we should have no problems supplying your requirements for the next twelve months.

We have certainly enjoyed the privilege of supplying your requirements down through the past years, and are looking forward to continuing this most pleasant relationship to our mutual advantage.
