## RESOLUTION AWARDING BONDS AND FIXING RATE OF INTEREST

WHEREAS, by Ordinance No. 40-76, adopted August 16, 1976, this Council authorized the issuance of Municipal Garage Bonds, 1976 Series, in the principal amount of \$200,000, and said bonds were advertised for sale in accordance with the Uniform Bond Law of the Ohio Revised Code; and

WHEREAS, MAGNUS & COMPANY, CINCINNATI, OHIO bid

for said bonds at par and accrued interest plus a premium of \$ 668.00 , said bonds to bear (a different) ( chexsense) rate of interest (from) (ave) that contained in said resolution and in the notice of sale, namely, FIVE AND SEVEN-EIGHTS per cent ( 5 7/8%) per annum; and

WHEREAS, the Director of Finance of the City has determined that said bid is the highest bid based upon the lowest rate of interest and has accepted said bid, subject to approval by this Council;

NOW, THEREFORE, the Municipality of Centerville, Montgomery County, Ohio, hereby resolves:

SECTION 1. That acceptance by the Director of Finance of the bid of <u>MAGNUS & COMPANY</u>, of par for said \$200,000 of Municipal Garage Bonds, 1976 Series, plus a premium of \$ <sup>668.00</sup>, said bonds to bear an interest rate of FIVE AND SEVEN-FIGHTS per cent

(5 7/8 %) per annum, be and the same is hereby approved.

SECTION 2. That the rate of interest set forth in Ordinance No. 40-76 is hereby (revised to be) (confirmediate) FIVE AND SEVEN-EIGHTS per cent (5 7/8 8) per annum.

SECTION 3. That this Council hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That a copy of this resolution be certified to the County Auditor of Montgomery County, Ohio.

SECTION 5. That pursuant to the Charter of the City of Centerville, this resolution shall be in full force and effect from and immediately after its adoption.
