A RESOLUTION ADOPTING A PROCEDURE FOR THE PLANNING AND DEVELOPMENT OF 35.506 ACRES PURCHASED BY THE CITY OF CENTERVILLE.

WHEREAS, the City of Centerville has purchased 35.506 acres of land located on the north side of E. Spring Valley Road for municipal purposes; and

WHEREAS, the Council desires to have the planning and development of said tract handled in an orderly manner by the appropriate boards and commissions of the City which are properly to be involved;

NOW, THEREFORE:

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

- Section 1. The overall responsibility for the planning and development of the said 35.506 acre tract shall be that of the Centerville Planning Commission. Its duties shall include but not be limited to the following: study and determination of the types of facilities to be placed on the premises and the activities to take place thereon; coordination of the duties and responsibilities of the various other city boards which may be involved; and final determination as to responsibility in the event of any conflict between one or more boards or commissions as to jurisdiction.
- Section 2. The Centerville Planning Commission shall prepare a plan for the development, including a statement of the involvement and areas of responsibilities of other boards and commissions not inconsistent herewith, and present same to the Council for approval or modification by motion.
- Section 3. All facilities or plans involving the youth of the community shall be the responsibility of the Youth Board provided, that where youth recreation is involved, the Youth Board shall coordinate its plans with the Park and Recreation Board.
- Section 4. General responsibility for parks and recreational facilities shall be the obligation of the Parks and Recreation Board except that where youth activities are involved it shall coordinate with the Youth Board; where beautification is involved it shall coordinate with the City Beautiful Commission and where fine arts may be involved it will coordinate with the Arts Commission.
- Section 5. General responsibility for the planting, fencing, installation of walkways, fountains and other items of beautification shall be the responsibility of the City Beautiful Commission, coordinating its activities with other boards and commissions as provided for herein.

Section 6. General responsibility for any fine arts facilities and any statuary or other items of art to be placed on the facility shall be the responsibility of the Arts Commission which shall coordinate its efforts with the other commissions and boards.

Section 7. Once the Planning Commission has developed its plan as provided for in Section 2 and same has been approved by Council, it shall meet with the chairmen of each of the other boards and commissions to develop areas of responsibilities and duties, not inconsistent herewith; develop a plan for coordination of duties and a plan for liaison among the various boards and commissions involved. It is suggested that the various boards and commissions provide for liaison representatives to be present at all board or commission meetings where planning and development of the said tract is under discussion.

Section 8. The Planning Commission may, but shall not be required, to delegate its duties hereunder to a temporary committee composed of representatives of the various involved boards and commissions which committee shall act in lieu of the Planning Commission in connection with the duties and responsibilities created herein and said committee may submit its reports and recommendations directly to Council or to Council through the Planning Commission as the Planning Commission may direct.
