
WHEREAS, the City advertised for bidders to furnish trees and plants for the City of Centerville, pursuant to specifications prepared by the City and

WHEREAS, Countryside Nursery and Landscaping, Inc. was the lowest and best bidder;


NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPALITY OF CENTERVILLE THAT:



TREE WATERING

Bid shall include the following:

FREQUENCY - All trees included in bid shall be watered on or about June 15, July 15, August 15, and September 15, 1975.

QUANTITY - 6 gallons per inch of trunk diameter.

QUALITY - Trees shall be watered for that period of time necessary to allow penetration of mulch and root area without flushing the surface of soil and mulch.

OPTION 1 - The City shall have the option of cancelling this contract in the event of ample rainfall.

OPTION 2 - The City shall have the option of requiring spring watering in the event of an early drought.
