A RESOLUTION OBJECTING TO APPLICATION NO. 8268054
TO THE OHIO DEPARTMENT OF LIQUOR CONTROL BY DALE
R. SMITH AND EDWARD C. KOSTIC DOING BUSINESS AS
FAR HILLS KITCHEN, 6220 FAR HILLS AVENUE, CENTERVILLE,
OHIO FOR A D-5 LIQUOR PERMIT.

Whereas, the City of Centerville has been notified pursuant to
Section 4303.261 Ohio Revised Code of the application by Dale R. Smith
and Edward C. Kostic doing business as Far Hills Kitchen for a D-5 liquor
permit; and

Whereas, by virtue of said statute a municipality may object to the
issuance of such permit on the grounds of reputability of the applicant or
suitability of location; and

Whereas the Council of the City of Centerville deems that the
location of the proposed use is not suitable because said applicants have
not complied with the requirements of Ordinance 15-61, The Zoning Ordinance
of the City of Centerville as amended by Ordinance Number 86-71;

Whereas, unless and until the requirements of said ordinance are
met said location is not suitable by virtue of its being a potential zoning
violation;


Now Therefore

The Municipality of Centerville hereby resolves:


Section 1. That the City of Centerville hereby objects to Application
No. 8268054 by Dale R. Smith and Edward C. Kostic doing business as
Far Hills Kitchen to the Ohio Department of Liquor Control for a D-5 liquor
permit for the reason that the proposed location is not suitable as more fully
set forth in an additional and separate statement, which statement the Clerk
of Council is hereby directed and authorized to prepare, execute, and file,
together with a certified copy of this resolution, with Richard E. Guggen-
heim, Director, Department of Liquor Control.

Section 2. This Resolution shall become effective immediately
upon adoption.
