

RESEARCH PROPOSAL

Submitted to:

Mr. Charles A. McQueeney, Jr. Councilman and Chairman Committee for Community Relations & Promotion City of Centerville, Ohio 45459

Purpose:

Basically, the intent of the survey will be to improve the communications—service flow between the City of Centerville and its citizens by determining, measuring, and evaluating the opinions and attitudes held by such citizens in regard to a number of diverse but mutually critical—interactive areas of city—provided services. Some areas to be probed might include refuse collection, street maintenance, police protection, recreational services, the quality and adequacy of interactions between City Officials and individual citizens, etc., zoning priorities, predisposition toward apartments, condominiums, etc.

In this way, the City of Centerville will not only be better able to provide its citizens with the right quantity and quality of those services which they desire most, but they will also possess a valuable "Benchmark" of citizen attitudes and opinions against which to measure future trends and findings.

Methodology:

Initially, it is recommended that the basic research design be based upon a telephone interview format which would be conducted by professionally trained interviewers within a single sample block as is below:

The suggested sample size will assure a reliability quotent of 95% within a standard deviation of (+) or (-) 5% and is statistically totally adequate and dependable. Actual responses will be selected on a random, representative, proportionate, systematic sample basis from a serial list source such as: for example, a City Directory or a listing of telephone numbers in the Centerville exchange.

Questionnaire format will be designed so as to elicit maximum response and effectiveness within an interview format not to exceed approximately 7-10 minutes per call. All interviews will be analyzed and interpreted on an item analysis basis. Throughout, the total emphasis will be upon maximum quantity of output.

Including all initial discussion and design formulation, sample selection, interviewer training, actual interviewing, tabulating, and analyzing data on an item analysis basis and presentation of multiple copies of the final report.

We propose a total cost of \$1,650.00 for the foregoing telephone survey. However, we will apply toward that cost \$250.00 previously agreed to for initial proposal formulation and preparation of the attached rough draft questionnaire. For a cost of \$1,900.00 we can increase the survey reliability by conducting the survey using an "in-person" interview format. Again, the \$250.00 proposal formulation fee would apply towards the total cost.
