SPONSORED BY COUNCILMAN John Davis ON THE 19th DAY OF
June, 1972.

A RESOLUTION RATIFYING THE ACTION OF THE CITY
MANAGER IN EXECUTING A CONTRACT WITH THE
STANDARD OIL COMPANY OF OHIO FOR THE PURCHASE
OF BULK GASOLINE FOR CITY USE PURSUANT TO
AUTHORITY IN A MOTION PASSED BY THE COUNCIL
ON JUNE 5, 1972.

WHEREAS, the City of Centerville, in accordance with its standard
bidding procedure, requested bids from various oil companies to supply
gasoline for the needs of the City for the year; and

WHEREAS, the Standard Oil Company of Ohio submitted the lowest and
best bid for the sale of said gasoline, a copy of which bid is attached hereto,
marked Exhibit "A" and made a part hereof; and


WHEREAS, on June 5, 1972, the bidding was discussed by the Council
at an open meeting and the Council, by motion, authorized the City Manager
to enter into a contract with the Standard Oil Company of Ohio for the purchase
of said gasoline;
