Mr. MCCLELLAN moved the adoption of the following Resolution:

WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said <sup>3</sup> VILLAGE OF CENTERVILLE

MONTGOMERY

County, Ohio; therefore, be it

RESOLVED, By the <sup>2</sup> COUNCIL of the

VILLAGE OF CENTERVILLE, MONTGOMERY

County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy <sup>4</sup> AN ADDITIONAL

tax in excess of the ten mill limitation

for the benefit of VILLAGE OF CENTERVILLE

(Name of Subdivision)

for the purpose of <sup>5</sup> ~~POLICE DEPARTMENT~~ MAINTENANCE

AND OPERATIONS Providing and maintaining

Motor Vehicles, Communications, and other equipment, used

directly in the operation of a Police Department, or the

Payment of salaries of permanent police personnel

at a rate not exceeding 1 mills for each one dollar of valuation, which amounts to 10 CENTS

(Rate expressed in dollars and cents)

for each one hundred dollars of valuation for

5 YEARS

and, be it further (Life of indebtedness or number of years the levy is to run)

<sup>6</sup>RESOLVED, That said levy be placed upon the tax lists of the current tax year in compliance with the provisions of Sec. 5705.34, ~~CURRENT TAX BUDGETS STARTING~~ <sup>6</sup> after the February settlement next succeeding the election, if <sup>7</sup> ~~WITH FIRST HALF COLLECTION~~ 1968

THE MAJORITY of the electors voting thereon vote in favor thereof; and, be it further

RESOLVED, That the Clerk of this <sup>2</sup> COUNCIL OF THE VILLAGE OF CENTERVILLE, OHIO be and he is

hereby directed to certify a copy of this Resolution to the Board of Elections, MONTGOMERY

County, Ohio, prior to the fifteenth day of September 19 67, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.<sup>8</sup>

8. This notice to be given by the Board of Elections shall be published in a newspaper of general circulation in the subdivision once a week for four consecutive weeks prior to the election.
