

RESOLUTION NO. # 2-64

RESOLUTION DECLARING IT NECESSARY TO IMPROVE STREETS, AVENUES AND PUBLIC HIGHWAYS IN THE VILLAGE OF CENTERVILLE, OHIO, HEREINAFTER NAMED, BY LIGHTING THE SAME WITH ELECTRICITY.

BE IT RESOLVED by the Council of the Village of Centerville, Ohio, three-fourths of the members elected thereto concurring that:

SECTION 1.

It is necessary to improve the streets, avenues, public highways and public places in the Village of Centerville, Ohio, by lighting the same with electricity.

The extent of the lighting in the zones aforesaid shall be in accordance with the plans, specifications and estimates heretofore prepared by the legislative authority of the Village of Centerville and now on file in the office of the Clerk of said Village and said plans, specifications and estimates be and the same are hereby approved.

SECTION 2.

The following streets, avenues, public highways and public places shall be lighted in accordance with this Resolution.

SECTION 3.

The cost of said improvement shall be paid as follows:

(a) Twenty (20 %) per cent of the total cost shall be paid by the Village of Centerville, Ohio;

(b) Expense of surveys and of printing and publishing the notices, resolutions and ordinances required and miscellaneous other costs shall be paid out of the General Fund of the Village of Centerville which will be in excess of the Village's share;

(c) All other remaining costs shall be paid by assessments upon the described lots and lands, to-wit:

All lots and lands abounding and abutting upon the aforesaid streets, avenues, public highways and public places as are hereinbefore described in Section 2 of this Resolution.

SECTION 4.

The assessments so to be levied shall be paid in annual installments, which installments shall be certified by the Clerk of the Village to the Montgomery County Auditor as required by law.

SECTION 5.

Notice of the passage of this Resolution be given to the owners of the lots and lands to be assessed for the payment of the costs and expenses of such improvement by publishing a copy of this Resolution once a week for two consecutive weeks in a newspaper of general circulation within this Village.

SECTION 6.

This Resolution shall take effect and be in force from and after the earliest period allowed by law.
