RESOLUTION NO. 10

RESOLUTION AUTHORIZING THE BOARD OF COUNTY COMMISSIONERS OF MONTGOMERY COUNTY, OHIO, TO ASSESS REAL ESTATE WITHIN THE VILLAGE OF CENTERVILLE, OHIO, FOR CERTAIN PUBLIC IMPROVEMENTS.

WHEREAS, the Board of County Commissioners of Montgomery County, Ohio, proposes to provide trunk sewer service to the corporate limits of the Village of Centerville, Ohio, thereby making public sewer facilities available to that part of the Village of Centerville which is within the North Holes Creek Sewer District; and

WHEREAS, it is necessary and in the public interest that the said Board of County Commissioners of Montgomery County, Ohio, assess the owners of real property within the Village of Centerville in the manner provided by law, for the proportional and reasonable cost of providing trunk sewer service to the said Village of Centerville; and

WHEREAS, the Village of Centerville, by its Village Council duly authorized, wishes to authorize the said County Commissioners to make such district assessment within the Village of Centerville in order to provide a trunk sewer line to the corporate limits of the said Village, said district assessment to be at the rate of approximately ONE HUNDRED THIRTY-FIVE DOLLARS (\$135.00) per acre of benefitted real property;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Centerville, State of Ohio, three-fourths of the members elected thereto concurring:

Section I. That the Board of County Commissioners of Montgomery County, Ohio, is hereby authorized to make assessment within the Village limits of Centerville, Ohio, against real

estate within the Village and to include benefitted real property lying within the corporate limits of Centerville as a part of the North Holes Creek Sewer District for purposes of assessment on an acreage assessment basis, said benefitted real property to be assessed at the rate of approximately ONE HUNDRED THIRTY-FIVE DOLLARS (\$135.00) per acre against those parcels of real estate lying within the Village, and also within the boundaries of the North Holes Creek Sewer District; provided, however, that such district assessment shall be at the same rate for all parcels of real estate within the improvement district, whether within or without the Village of Centerville.

Section II. That funds arising by such district assessment shall be used to provide a trunk sewer facility to the corporate limits of the Village of Centerville, Ohio, adequate in size and sufficient in structure to provide efficient sewer service for that part of Centerville which lies within the North Holes Creek Sewer District.
