

VILLAGE OF CENTERVILLE, OHIO

RESOLUTION NO. 45 - 1958

BEING A RESOLUTION OF NECESSITY BY THE VILLAGE COUNCIL OF THE VILLAGE OF CENTERVILLE, OHIO, DECLARING THE NECESSITY TO CONSTRUCT A SEWAGE DISPOSAL WORKS CONSISTING OF A TREATMENT PLANT AND OTHER PROPER AND NECESSARY APPURTENANCES THERETO, TO PROVIDE FOR THE TREATMENT AND DISPOSAL OF SEWAGE FROM LOTS 3349 THROUGH 3565, INCLUSIVE, OF HERBERT C. HUBER PLAT 25, CENTERVILLE, OHIO, AS RECORDED IN PLAT BOOK QQ, PAGES 52 and 53, OF THE PLAT RECORDS OF MONTGOMERY COUNTY, OHIO.

WHEREAS, the owner of all of the lots and lands known and described as Lots 3349 through 3565, inclusive, of Herbert C. Huber Plat 25, Centerville, Ohio, as recorded in Plat Book QQ, Pages 52 and 53 of the Plat Records of Montgomery County, Ohio, has petitioned for the construction of a sewage disposal works, consisting of a treatment plant and other proper and necessary appurtenances thereto, to provide for the treatment and disposal of sewage from the said lots of the said Herbert C. Huber Plat 25, only; and

WHEREAS, said petition does not include a request for construction of a collection system ancillary to such sewage disposal works.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Centerville, State of Ohio:

1. That it is necessary and in the public interest that a sewage disposal works consisting of a treatment plant and other proper and necessary appurtenances thereto, to provide for the treatment and disposal of sewage from Lots 3349 through 3565, inclusive, of Herbert C. Huber Plat 25, Centerville, Ohio, as recorded in Plat Book QQ, Pages 52 and 53 of the Plat Records of Montgomery County, Ohio, be constructed at the earliest possible date;

2. That such sewage disposal works be constructed in accord with plans and specifications prepared by Ralph L. Woolpert Company, Consulting Engineers, Dayton, Ohio, which shall be furnished by and at the expense of said petitioner, which plans and specifications are hereby approved;

3. That bids for contracts for the construction of such sewage disposal works, in accord with such plans and specifications, be requested by Leo Wall, Engineer of the Village of Centerville, Ohio, in accordance with the statutes of the State of Ohio, and that such construction be done under the supervision of the said Leo Wall.

4. That the whole cost of the construction of said sewage disposal works shall be assessed against the petitioning owner of said lots and lands which are to be especially benefited thereby, being the same real property as above described, and which said lots and lands are hereby determined to be specifically benefited by said improvement; and the cost of the said construction of the said sewage disposal works shall consist of all costs and expenses incurred by the Village of Centerville, Ohio, including the expense of the preliminary and other surveys and of printing and publishing notices, resolutions and ordinances required, and the serving of said notices, all costs of construction together with interest on notes and bonds issued in anticipation of the collection of deferred assessments and all other necessary expenditures.

5. That the assessment shall be paid in full, in cash, at such time as the construction of said sewage disposal works is completed and the assessment therefor is levied in accordance with law.

6. This resolution shall take effect and be in force from and after the earliest period allowed by law.
