

6. Completed joint between old and new will be coated with asphaltic seal, RC-2 or equivalent, or heat sealed with a suitable flame.

Restoration of public ways shall be completed within three (3) days of start of excavation.

Cuts into concrete streets shall be restored in the same manner except that there will be only a six (6) inch concrete cap.

Upon completion of restoration the Contractor shall notify the Village Engineer. After inspection and acceptance of the restoration by the Village Engineer, the Clerk-Treasurer shall return the deposit to the grantee of this permit. If the restoration is not satisfactorily made within a period of two (2) weeks from the date of start of excavation then the Village Council shall expend the necessary amounts out of the said deposit to complete the restoration in the required manner."

SECTION 3. That Section 7 of Ordinance Number 13-1959 be deleted and the following substituted in lieu thereof:

SECTION 7. By reason of the extensive lines, pipes, and conduits within the Village of Centerville, Ohio, a contractor or a public utility firm or corporation, may, at its option, be exempted from that part of Section 2 hereof which requires a cash, certified check or postal money order security deposit. If such contractor or public utility firm or corporation shall elect to be so exempted then it shall forthwith deposit, with the Clerk-Treasurer of the Village of Centerville, Ohio, a performance bond in the sum of not less than \$1,000.00 with corporate surety acceptable to the Village Council to insure the restoration to its original pavement condition of any street, sidewalk space, sidewalk, alley or public way which may be excavated in pursuance of a permit issued under this Ordinance.

SECTION 4. This Ordinance shall take effect from and after the earliest time allowed by law and all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by the other specific appropriations herein made.

ORDINANCE NO. 5-66

AN ORDINANCE CHANGING CERTAIN HOUSE NUMBERS ON CLARERIDGE DRIVE AND CLARERIDGE LANE IN THE VILLAGE OF CENTERVILLE, OHIO

WHEREAS, Clareridge Drive and Clareridge Lane are one road, said road being known as Clareridge Drive in that portion thereof which runs east and west and Clareridge Lane in that portion thereof which runs north and south, and
