

bearing a different rate of interest from that hereinbefore fixed; provided, however, that where a fractional interest rate is bid, such fraction shall be one-eighth of one per cent or a multiple thereof; the amount of cash or checks to accompany bids shall be at least one per cent of the amount of the bond issue; the proceeds from the sale of said bonds, except the premium and accrued interest thereon, shall be used for the purpose aforesaid and for no other purpose; the premium and accrued interest received from such sale shall be transferred to the Bond Retirement Fund to be applied to the payment of the principal of and interest on said bonds in the manner provided by law.

Section 6. The Village Clerk is hereby directed to forward a certified copy of this ordinance to the County Auditor of Montgomery County, Ohio.

Section 7. That this ordinance is hereby declared to be an emergency measure for the reason that the public peace, health, safety, and welfare of the inhabitants of the village require the issuance of said bonds immediately in order that the construction of the Municipal Garage may be commenced without delay, and it shall take effect upon its passage.

ORDINANCE NO. 10-1966

AN ORDINANCE AMENDING ORDINANCE NO. 2-66 WHICH ESTABLISHED AND FIXED THE COMPENSATION AND CONDITIONS OF EMPLOYMENT AND PROMOTION OF MEMBERS OF THE POLICE DEPARTMENT OF THE VILLAGE OF CENTERVILLE, OHIO.

Whereas, it is deemed necessary for the protection of the Public Health, Safety, and Welfare that this Ordinance take effect at the earliest date allowed by law.

BE IT ORDAINED by the COUNCIL of the VILLAGE OF CENTERVILLE, OHIO, that:

Section 1. Section 1. of Ordinance No. 2-66 is hereby amended to read as follows:

Section 1.

(a) The annual salaries of members of the Police Department of the Village of Centerville, Ohio, are hereby fixed, effective January 1, 1966, as follows:

Chief of Police	\$7,750.00
Sargeants	6,000.00 each
Patrolmen	5,000.00 each

(b) Effective July 1, 1966, the annual salaries of members of the said Police Department shall be as follows:

Chief of Police	\$8,370.00
Sargeants	6,480.00 each
Patrolmen	5,400.00 each

(c) Each member of the Police Department shall receive an additional increase in salary of \$324.00 per year after his first full year of service in the Department.

(d) All salaries and other forms of compensation for members of the Police Department of the Village of Centerville, Ohio, shall be reviewed by the Village Council or a duly authorized committee thereof in December of each year.

Section 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed, and this ordinance shall take effect from and after the earliest period allowed by law.

✓ ORDINANCE NUMBER 11-1966

VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE TO PROHIBIT THE DEPOSIT, STORAGE, COLLECTION, OR MAINTENANCE OF JUNK, JUNK CARS, OR RUBBISH ON ANY PREMISES WITHIN THE VILLAGE OF CENTERVILLE, OHIO, EXCEPT AS OTHERWISE PROVIDED.

WHEREAS, the accumulation of junk, junk cars, and rubbish in open areas within the Village results in unsanitary and dangerous conditions.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Centerville, Ohio.

SECTION 1. That there is hereby enacted Section 36.31 of the Code of Ordinances of the Village of Centerville, Ohio, which shall be and read as follows:

36.31 - Deposit, Storage, Maintenance, or Collection of Junk, Junk Cars, or Rubbish Prohibited.

For the purpose of this section, Junk, Junk Cars, and Rubbish are defined as follows:

Junk. Junk is any wornout, cast-off, or discarded article or material which is ready for destruction or has been collected or stored for salvage or conversion to some other use. Any article or material which, unaltered or unchanged and without further reconditioning, can be used for its original purpose as readily as when new shall not be considered junk.

Junk Cars. Junk Car is any used car or motor vehicle not in the process of reconditioning, which has been abandoned for use as a motor vehicle on public highways and which is in unsafe operating condition and shall have remained in such condition for a period in excess of thirty (30) days. Portions of junk cars, such as hoods, fenders, radiators, rims, motors, etc. not being utilized for the repair of a motor vehicle, shall be considered as junk.

Rubbish. Rubbish means and includes wire, chips, shavings, bottles, broken glass, crockery, tin, cast or wooden ware, boxes, rags, dead weeds, stumps, tree trunks, brush, paper circulars, hand bills, boots, shoes, ashes, or any waste material other than garbage or offal.

No person, firm, or corporation shall deposit, store, maintain, collect, or permit the storage, deposit, maintenance, or collection of any junk, junk cars, or rubbish, in unenclosed areas on his premises or any premises under his control which are unenclosed, or in any other place within the municipality, except as expressly provided by law.

The provisions of this ordinance shall not apply to the deposit and storage of junk, junk cars, or rubbish in regularly established dumps, junk yards, or salvage and scrap metal yards within the Village of Centerville.

Enforcement: Any person violating the provisions of this ordinance shall, within thirty (30) days after notification of said violation by a person acting on behalf of the Village of Centerville, remove or cause to be removed any junk, junk cars, or rubbish, or have the same placed in an adequate enclosure or building; and in the event of failure, within said thirty (30) day period, to comply with said notice, he shall be deemed guilty of violating the provisions of this ordinance.

Penalty: Whoever violates any provision of this ordinance shall be fined not more than Fifty Dollars (\$50.00) for the first offense and not more than Five Hundred Dollars (\$500.00) for each subsequent offense. Any such violation shall constitute a separate offense on each successive day continued.

SECTION 2. That this ordinance is hereby declared to be an emergency measure in that the unrestricted accumulation of junk, junk cars, and rubbish in open areas within the municipality could result in unhealthful and dangerous conditions within the city to the general detriment of its citizens, and therefore, this ordinance shall go into effect immediately upon its passage and signing by the Mayor.
