ORDINANCE NUMBER 1-63 VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE AMENDING ORDINANCE NUMBER 16 DATED NOVEMBER 20, 1959, BY ADDING THERETO SECTION 28.241 TO THE CODE OF ORDINANCES OF THE VILLAGE OF CENTERVILLE, OHIO, REGULATING THE TRIMMING AND PLANTING OF TREES AND SHRUBS WITHIN THE VILLAGE OF CENTERVILLE, MONTGOMERY COUNTY, OHIO.

WHEREAS, it is necessary to provide for the regulation and control of the trimming and planting of trees and shrubs within the Village of Centerville, Montgomery County, Ohio,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, MONTGOMERY COUNTY, OHIO, THAT:

SECTION 1. TREES DEFINED:

The word "Trees" as used in this Ordinance shall be construed to include shrubs.

SECTION 2. OVERHANGING TREES:

The owner of each lot or parcel of land within the Village of Centerville, Montgomery County, Ohio, upon which a tree stands with any part of said tree upon or overhanging a public thoroughfare, and the owner of each such lot or parcel of land abutting a public throughfare upon whic throughfare and in front of which lot or parcel of land a tree stands, shall conform to the following regulations:

- (A) Said owner shall trim or cause to be trimmed, said tree, so that the same shall not obstruct the free passage of light from any street-light to the street, sidewalk and/or public thoroughfare.
- (B) Said owner shall trim or cause to be trimmed, said tree, so that a clear height of thirteen and one-half feet between the lowest branches of the same and the street, alley, sidewalk or public thoroughfare is maintained.
- (C) Said owner shall trim or remove, as the cause may require, every dead, decayed or broken tree hereinabove described, or part thereof, so that the same shall not fall to the street, alley, sidewalk, public thoroughfare and right of way.

SECTION 3. Said Village of Centerville, Ohio, shall have the right to cause to be trimmed any trees standing in violation of Section 2. of the within ordinance and that said Village shall give the property owner ten (10) days notice in writing and in event property owner fails to comply with said notice, the costs incurred by said Village shall be paid by property and that if not paid same shall be certified by the Village Clerk to the County Auditor as a special assessment to be placed on the tax duplicate and to be collected as other taxes.

SECTION 4. PLANTING OF TREES AND SHRUBS:

No trees or shrubs shall be planted between the sidewalk and the curbline nor within the right of way within the Village of Centerville, Ohio.
