ANNUAL APPROPRIATION ORDINANCE (VILLAGE)

AN ORDINANCE TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF CENTERVILLE, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31st, 1962.

Section 1. Be it Ordained by the Council of the Village of Centerville, State of Ohio, That, to provide for the current expenses and other expenditures of the said Village of Centerville during the fiscal year ending December 31st, 1962, the following sums be and they are hereby set aside and appropriated as follows, viz:

Section 20. And the Village Clerk is hereby authorized to draw his warrants on the Village Treasurer for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefor, approved by the board of officers authorized by law to approve the same, or an ordinance or resolution of council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law and ordinance. Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the village, and for purposes other than those covered by the other specific appropriations herein made.

Section 21. This ordinance shall take effect at the earliest period allowed by law.

ORDINANCE NUMBER 3 - 1962
VILLAGE OF CENTERVILLE, OHIO

ORDINANCE ACCEPTING APPLICATION FOR ANNEXATION OF TERRITORY.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, OHIO.

Section 1. That the Application of Hugh L. Lagedrost, et al. for the annexation of the following described territory in the County of Montgomery, to-wit:

Located in Sections 20 and 26, Town 2, Range 6 MRs., Washington Township, Montgomery County, State of Ohio, and being an area described as follows: Beginning at the northwest corner of the present Corporation of the Village of Centerville, said point being on the south line of said Section 26 and at the intersection of the centerline of Alexandersville-Bellbrook Pike with the centerline of Dayton and Lebanon Pike (State Route 48); thence northwardly with the centerline of said Dayton and Lebanon Pike to the centerline of Whipp Road; thence eastwardly with the centerline of said Whipp Road to the west right-of-way of the Pennsylvania Railroad (C.L. & N. Division); thence southwardly with the west right-of-way line of said Pennsylvania Railroad to the south line of said Section 20 and the centerline of said Alexandersville-Bellbrook Pike; thence westwardly with the south line of said Section and the centerline of said Alexandersville-Bellbrook Pike to the southwest corner of said Section 20, the southeast corner of said Section 26, and the northeast corner of the present Corporation of the Village of Centerville; thence westwardly with the south line of said Section 26, the centerline of said Alexandersville-Bellbrook Pike, and the north line of said present Corporation of Village of Centerville to the point of beginning containing five hundred thirty-four and 268/1000 (534 268) acres, more or less.
