# ✓ ORDINANCE NUMBER 8 - 1962 VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE AMENDING ORDINANCE NUMBER 16, DATED NOVEMBER 30, 1959, BY ADDING SECTION 26.3 OF THE CODE OF ORDINANCES OF THE VILLAGE OF CENTERVILLE, OHIO, RESTRICTING THE PARKING OF TRUCKS, TRACTORS AND ALL TYPES OF TRAILORS ON THE STREETS OF THE VILLAGE OF CENTERVILLE, OHIO.

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, OHIO, THAT:

SECTION 1. The parking of all trucks, tractors and all types of trailors on the streets of The Village of Centerville, Ohio, be and the same is hereby restricted to two (2) hours, excepting emergency vehicles and delivery or service vehicles while engaged in such delivery or service.

SECTION 2. Penalty - It shall be a misdemeanor for any person to violate the provisions of this Ordinance and whoever violates within Ordinance shall be fined not less than Five (\$5.00) Dollars nor more more than twenty-five (\$25.00) Dollars for each offense.

SECTION 3. This Ordinance shall revoke and rescind Ordinance Number 6 - 1962 of the Village of Centerville, Ohio, and all other Ordinances or Resolutions in conflict within.
