

ORDINANCE NUMBER 6-1960  
VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE TO SUPPLEMENT THE "ZONING ORDINANCE OF 1955" FOR THE PURPOSE OF ESTABLISHING A VILLAGE PLANNING COMMISSION, THE TERMS OF, THE REMOVAL OF, VACANCIES CREATED BY, AND THE DUTIES AND POWERS OF ITS MEMBERS, BY THE ADDITION OF SUPPLEMENTAL ARTICLE XXVI.

WHEREAS, in the year 1955, the Legislative Authority of the Village of Centerville passed an ordinance known as the "Zoning Ordinance of 1955", and that this ordinance does not establish a Village Planning Commission or the terms of, removal of, vacancies created by, or the duties and powers of its members; and

WHEREAS, it is deemed necessary to supplement the "Zoning Ordinance of 1955" to provide for the above matters by the addition of an article thereto, the same to be numbered Article XXVI;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Centerville, State of Ohio:

Section 1. That the "Zoning Ordinance of 1955" be, and the same hereby is supplemented by the addition of supplemental Article XXVI, to read as follows:

ARTICLE XXVI

VILLAGE PLANNING COMMISSION

SECTION 1. Constituency. The legislative authority of The Village of Centerville hereby establishes a Village Planning Commission of five (5) member, consisting of the mayor, one member of the legislative authority to be elected thereby for the remainder of his term as such member of the legislative authority, and three (3) citizens of the village to be appointed by the mayor for terms of six (6) years each, except that the term of one of the members of the first Village planning Commission shall be for four (4) years and one for two (2) years. All such members shall serve without compensation.

SECTION 2. Removals and Vacancies. Any member or members can be removed from his or their office only by a majority vote of the Village Planning Commission or by any similar action taken by the Council.

Any vacancy that is made on the Commission, shall be filled by appointment by the Mayor of the Village and approved by the Council. Any appointment of this kind is to serve the unexpired term of the vacancy.

SECTION 3. Organization. The members of this Commission shall meet and from their group elect the following officers: A President, a Vice-President, and a Secretary-Treasurer. Also this Commission may create any other positions as they may see fit to properly carry on the full duties of this Commission, with the approval of any such positions created, by the Council of the Village. Any special services as may be necessary with the approval of Council can be obtained and all such assistants or special services that are deemed necessary by the Commission before any compensation shall be made, must be approved by Council, also be written in their minutes. Compensation to be made from funds appropriated by Council.

SECTION 4. Rules. The members of this Commission shall hold as many meetings as may be necessary to take care of the business at hand. They shall adopt a set of rules for their procedure of business, also make a record of all such meetings and decisions. Three members present shall constitute a quorum to transact business. The Commission shall make reports to Council as may be required by Council, and the minutes of any and all meetings held during each month shall be read to the council at each regular council meeting.

SECTION 5. Powers and Duties. The general powers and duties of this Commission to be performed and exercised are herein provided for and in the general accord with the ordinances of the Village.

1. The Planning Commission shall have any other powers that may be granted or conferred upon it by Council or with such other powers as may be prescribed to carry out the duties of this Planning Commission.

2. The Planning Commission shall have all powers now or hereafter conferred upon, to perform all duties which may be imposed upon the Planning Commission, or Commissions in cities, and Villages, by the Revised Code of Ohio.

Section 2. That all existing ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. For the reasons stated in the preamble hereof, this ordinance is declared to be an emergency measure and shall take effect immediately upon its passage.

ANNUAL APPROPRIATION ORDINANCE (VILLAGE)

AN ORDINANCE TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF CENTERVILLE, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31st, 1960.

Section I. Be it Ordained by the Council of the Village of Centerville, State of Ohio, that, to provide for the current expenses and other expenditures of the said Village of Centerville during the fiscal year ending December 31st, 1960, the following sums be and they are hereby set aside and appropriated as follows, viz:

Section II. That there be appropriated from the GENERAL FUND:

Section III. That there be appropriated from the GENERAL FUND for CONTINGENCIES for purposes not otherwise provided for, to be expended in accordance with the provisions of Section 5705.40 R.C., the sum of \$ 1,204.81

That there be transferred from the GENERAL FUND to the SAFETY FUND the sum of \$15,000.00 (if revenues from sources other than taxes are to be deposited in the Safety, Service, etc., Funds as heretofore, an Ordinance to this effect must be passed by Council, Sec. 5705.12 R.C.); and that there be appropriated from said Safety Fund the following:
