Provided further that the appropriation for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the village, and for purposes other than those covered by the other specific appropriations herein made.

✓ ORDINANCE NUMBER 8-1960  
VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE TO AMEND CERTAIN PROCEDURES IN ORDINANCE NUMBER 13, 1959, PROVIDING FOR OBTAINING PERMITS RELATIVE TO DIGGING AND EXCAVATION INTO ANY STREET, SIDEWALK, SIDEWALK SPACE, ALLEY OR PUBLIC WAY.

BE IT ORDAINED by the Council of the Village of Centerville, Ohio:

Section 1. That Section 2 of Ordinance No. 13-1959, be amended to read as follows:

Section 2. The person, firm or corporation desiring to acquire such a permit shall make application, in writing, to the Chairman of the Street Committee of the Village of Centerville. Before the Street Committee shall issue such permit, the applicant shall be required to pay a permit fee of Twenty Dollars (\$20.00) to cover necessary administrative and engineering expenses and to deposit the sum of

One Hundred Dollars (\$100.00), or a sum computed at the rate of Two Dollars (\$2.00) per lineal foot proposed by the applicant to be excavated, whichever sum is greater. The permit fee and the deposit so required shall be paid in cash, certified check or postal money order to the Chairman of the Street Committee of the Village Council who shall, in turn, transfer the deposit to the Clerk-Treasurer of the Village Council and thereafter the permit shall issue."

Section 2. That all provisions of Ordinance Number 13-1959, inconsistent with the foregoing amendment shall be repealed immediately upon passage of this ordinance in the manner provided by law.

Section 3. The foregoing ordinance is declared to be an emergency measure and shall take effect immediately upon its passage; the said emergency is declared to exist because of the immediate necessity of clarifying part of the previously enacted ordinance hereinbefore referred to, which controls the installation of public improvements, same being a matter of public health.

✓ ORDINANCE NUMBER 9-1960  
VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE AMENDING ORDINANCE NUMBER 12-1959, SECTION 1, "B", and SECTION 2, OF THE VILLAGE OF CENTERVILLE, OHIO, REGULATING STORAGE, COLLECTION AND DISPOSAL OF GARBAGE AND RUBBISH.

WHEREAS, It is deemed necessary to amend the definition of the term "rubbish", as used in Ordinance Number 12, 1959, and, also, to establish specifications for containers and storage of garbage and rubbish;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Centerville, Ohio:

Section 1. That Ordinance Number 12, 1959, Section 1, "B", be, and the same hereby is, amended to read, as follows:

"B. The term "rubbish" means ashes, glass, crockery, tin cans, paper, boxes, rages, old clothing, grass and shrubbery cuttings and all similar non-putrescible wastes. The term shall not include any materials such as earth, sand, brick, stone, plaster, or other similar substances that may accumulate as a result of construction operations or repairing or remodeling. The term shall include only such substances from dwelling units."

Section 2. That Ordinance Number 12, 1959, Section 2, be, and the same hereby is, amended to read, as follows:

"Section 2. Storage of Garbage and Rubbish.
