ORDINANCE NUMBER 2-1958

VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE TO PROVIDE FOR THE EMPLOYMENT OF AND TO FIX THE SALARY OF THE VILLAGE ENGINEER AND TO RATIFY AND APPROVE THE APPOINTMENT OF MR. LEO WALL AS SUCH VILLAGE ENGINEER.

BE IT ORDAINED by the Council of the Village of Centerville, State of Ohio:

<u>SECTION 1.</u> That the Village of Centerville, Ohio, shall be authorized to employ a qualified person to serve as the Village Engineer, who shall be a civil engineer, so licensed to practice such profession by the State of Ohio; that he shall serve under the authority of, and subject to the direction and control of the Village Council. His tenure shall be subject to the discretion of said council.

SECTION 2. That the duties of the Village Engineer shall be the planning, supervision and inspection of all public improvement and construction within the Village, as directed by Council, the Village Planning Commission, or delegated representatives or committees of either acting within the scope of their authority, and such supervision or inspection as may relate directly or indirectly to the enforcement of the zoning ordinances or building code, or Subdivision Regulations of said Village, or such other ordinances, resolutions or directives for the promotion of the public safety, health or welfare within the Village of Centerville.

SECTION 3. That the compensation to the Village Engineer for his professional services shall be a salary or retainer of not less than \$1,000.00 per annum, the rate of compensation to be fixed and earned in accordance with the following schedule:

Attendance at meetings with the Council, Village Officials or Boards - \$5.00.

Building permit inspection, each lot - \$5.00.

Hourly rate, other professional service and consultation - \$5.00 per hour; minimum charge of \$20.00 for each individual and separate assignment of work or consultation.

SECTION 4. That Mr. Leo Wall, 3721 Nyetha Drive, Dayton 49, Ohio, a registered and licensed civil engineer of the State of Ohio, is hereby employed as the Village Engineer for the Village of Centerville, Ohio, under the terms and conditions set forth above, his employment to be effective January 1, 1958, and thereafter to serve as provided by law and at the pleasure of this Council.

SECTION 5. This ordinance is passed as an emergency measure under the law of the State of Ohio, the existing emergency being the immediate need for continuous engineering services by competent and qualified personnel.

SECTION 6. That all ordinances or parts of ordinances inconsistent herewith shall be repealed and this ordinance shall take effect from and after the 6th day of January, 1958.

ORDINANCE NUMBER 3-1958 VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE TO FIX THE SALARY OF THE VILLAGE MARSHAL AND TO CONFIRM THE APPOINTMENT OF JAMES R. SMITH AS VILLAGE MARSHAL OF THE VILLAGE OF CENTERVILLE, OHIO.

BE IT ORDAINED by the Council of the Village of Centerville, State of Ohio:

SECTION 1. That effective January 1, 1958, the salary of the Village Marshal shall be Four Thousand Seven Hundred Dollars (\$4,700.00) annually, payable in equal monthly installments.

<u>SECTION 2.</u> That the duly appointed Village Marshal shall be paid a uniform allowance to be used by him for the purchase and replacement of the standard uniform of dress prescribed and authorized by the Village Council in the sum of Three Hundred Fifty Dollars (\$350.00) annually; and that said sum shall be paid to the Village Marshal at such times and in such amounts as the Village Council may direct.

SECTION 3. That the appointment of James R. Smith, 4 North Main Street, Centerville, Ohio, an elector of the said Village of Centerville, by the Mayor of Centerville as of the first day of January, 1958, is hereby ratified, approved and confirmed and he shall continue in office until removed therefrom as provided by law.

SECTION 4. That all ordinances or parts of ordinances inconsistent herewith shall be repealed and this ordinance shall take effect immediately, the same being passed as an emergency measure as provided by the statutes of Ohio, the said emergency existing by reason of the necessity for continuous police protection in the public interest and safety.

ORDINANCE NUMBER 4-1958 VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE PROVIDING FOR THE EMPLOYMENT OF A VILLAGE SOLICITOR FOR THE VILLAGE OF CENTERVILLE, OHIO.

BE IT ORDAINED by the Council of the Village of Centerville, State of Ohio:

SECTION 1. That legal counsel shall be provided for this Village in accordance with Revised Code Section 733.48 and the attorney employed as such counsel shall be known as the "Solicitor of the Village of Centerville." Such Solicitor shall be employed by Council for a period not exceeding two (2) years.

SECTION 2. The compensation payable to such Solicitor shall be made by a retainer of One Thousand Dollars (\$1,000.00) each year during the period of his service, which retainer shall be paid in quarterly installments of Hundred Fifty Dollars (\$250.00) each, which installment shall in turn be credited against the quarter-annual statement of the said Solicitor, which statements for legal counsel shall be rendered on the first day of the months of January, April, July and October.

SECTION 3. The Solicitor shall be an attorney at law, admitted to practice by the Supreme Court of Ohio. It shall be the duty of said Solicitor to act as attorney and counsel for the Village and its officers in their official capacity and as such attorney to prosecute and defend all actions by or against the Village or any department or officer thereof during the term of his employment; and to render legal opinions, counsel and advice to the Council and to any board, department or officer of the Village at any time upon request, and to attend meetings of Council and other boards or official committees as directed by the Mayor.

SECTION 4. Council hereby employs James T. Lynn, Jr., attorney at law, 316 Talbott Building, Dayton 2, Ohio, as the Village Solicitor effective January 1, 1958, in accordance with the foregoing provisions.

SECTION 5. This ordinance is passed as an emergency measure by reason of the immediate necessity for the employment of legal counsel to assist the Village in its many legal problems, and therefore shall take effect immediately.
