initial fee of \$5.00 shall not be refunded but shall be and remain the property of the Village the same as if said permit had been issued, as an administrative and inspection charge.

Section III. This Ordinance shall supersede all ordinances and parts of ordinances, or regulations, inconsistent herewith. This ordinance is declared to be an emergency measure, such emergency existing by reason of the immediate necessity for provinding for initial inspection and engineering date prior to issuance of building permits, so that the constituted authority charged with responsibility for issuance of permits may be fully informed and advised of data necessary for determining whether or not the permit shall issue.

ORDINANCE NUMBER 17-1958
VILLAGE OF CENTERVILLE, OHIO

BEING AN ORDINANCE OF THE VILLAGE COUNCIL OF CENTERVILLE, OHIO, TO ADOPT THE UNIFORM BUILDING CODE WHICH HAS HERETOFORE BEEN ADOPTED BY THE CITIES OF DAYTON, KETTERING AND OAKWOOD, OHIO AND MONTGOMERY COUNTY, OHIO.

BE IT ORDAINED, by the Village Council of the Village of Centerville, State of Ohio:

This Ordinance shall take effect immediately by reason of the emergency nature of the same. An emergency is declared to exist because of the immediate necessity of preventing dangerous and improperly constructed buildings and other structures from being built in this Village to the prejudice of the public health, safety and convenience.

> ORDINANCE NUMBER 18-1958 VILLAGE OF CENTERVILLE, OHIO

BEING AN ORDINANCE TO FIX THE COMPENSATION OF CERTAIN OFFICERS AND MEMBERS OF THE VILLAGE COUNCIL FOR THE NEXT ENSUING TERM OF OFFICE IN THE MANNER PROVIDED BY OHIO REVISED CODE, SECTION 731.13.

WHEREAS, it is deemed in the public interest to increase the compensation of the Mayor, Clerk-Treasurer and the members of the Village Council of Centerville, Ohio for the next ensuing term of office, beginning January 1, 1960, in order to more adequately and fairly compensate such officers and members of Council in accordance with increased duties and responsibilities,

NCW THEREFORE BE IT ORDAINED by the Village Council of the Village of Centerville, Ohio:

SECTION I. Beginning January 1, 1960, the annual salary of the Mayor of the Village of Centerville, Ohio, shall be the sum of ONE THOUSAND TWO HUNDRED FIFTY (\$1,250.00) DOLLARS.

SECTION II. Beginning January 1, 1960, the annual salary of the Clerk-Treasurer of the Village of Centerville, Ohio, shall be the sum of ONE THOUSAND TWO HUNDRED FIFTY (\$1,250.00) DOLLARS.

SECTION III. Beginning January 1, 1960, in accordance with Ohio Revised Code Section 731.13 applying to villages having an operating budget of more than \$25,000.00 annually, each member of the Village Council of Centerville, Ohio, shall be paid the sum of FIVE (\$5.00) DOLLARS each meeting of said Council attended by said member, provided however, that the number of meeting for which each member shall be paid such compensation shall not exceed TWENTY-FOUR (24) in any calendar year.

SECTION IV. All Ordinances and parts of Ordinances inconsistent herewith shall be repealed and this Ordinance shall take effect as provided herein on January 1, 1960.
