

ORDINANCE NUMBER 7 - 1954

Village of Centerville

AN ORDINANCE TO REVOKE AND REPEAL ORDINANCE NUMBER 6-1954 AND ORDINANCE NUMBER 6A-1954.

WHEREAS, additional water supply by contract with the Greater Moraine Water District, Montgomery County, Ohio, has ended the emergency condition with regard to water supply for the Village of Centerville, Ohio, heretofore existing; and

WHEREAS, it is deemed to be in the public interest to revoke and repeal Ordinance Number 6-1954 and Ordinance Number 6A-1954;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Centerville, Ohio.

Section 1. Ordinance Number 6-1954, Village of Centerville, Ohio, being an ordinance to regulate and control the consumption and use of water by customers of the Centerville, Ohio, Municipal Water Works System, is hereby revoked, repealed, set aside and held for naught.

Section 2. Ordinance Number 6A-1954, Village of Centerville, Ohio, being an ordinance to suspend temporarily the operation of Ordinance Number 6-1954 relating to the regulation and control of consumption and use of water by customers of the Centerville, Ohio, Municipal Water Works System, is hereby revoked, repealed, set aside and held for naught.

Section 3. This ordinance is passed this 6th day of December, 1954, and shall be and is effective immediately, in accordance with the statutes of the State of Ohio.

ORDINANCE NO. 8 - 1954

AN ORDINANCE FIXING THE PRICE WHICH THE DAYTON POWER AND LIGHT COMPANY, ITS SUCCESSORS AND ASSIGNS, MAY CHARGE FOR ELECTRIC LIGHT FURNISHED TO THE PUBLIC GROUNDS, STREETS, LANES, ALLEYS AND AVENUES IN THE VILLAGE OF CENTERVILLE, STATE OF OHIO, FOR A PERIOD OF FIVE (5) YEARS, COMMENCING ON THE 28TH DAY OF DECEMBER, 1954, AND DETERMINING THE MANNER IN WHICH SAID LIGHTING MAY BE FURNISHED, PROVIDED AND PAID FOR.

WHEREAS, there is on file with the Clerk of said Village complete plans and specifications for the lighting of the streets and public ways of the Village of Centerville with electricity, which plans and specifications provide for different type and rating of lights in different locations according to the local requirements, the lights being designated by lumens and classified as hereinafter set forth.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, STATE OF OHIO:

Section 1: That for a period of five (5) years, commencing on the 28th day of December, 1954, the price which may be charged by the Dayton Power and Light Company for electric light furnished to the Village of Centerville, Ohio, to light the streets, lanes, alleys, avenues and public places thereof in the manner and by the means set forth in the plans and specifications therefor on file with the Clerk of said Village, and as provided in this ordinance, shall be as follows:

2500 Lumen Aerial Lamps

For light supplied by means of twenty-five hundred (2500) nominal lumen aerial lamps, the price shall be \$30.00 per lamp, per year;

4000 Lumen Aerial Lamps

For light supplied by means of four thousand (4000) nominal lumen aerial lamps, the price shall be \$40.00 per lamp, per year;

15,000 Lumen Aerial Mercury Lamps

For light supplied by means of fifteen thousand (15,000) nominal lumen aerial mercury lamps, the price shall be \$70.00 per lamp, per year.

SECTION 2: That the minimum number of lamps of the various nominal lumen intensity to be used for the lighting of said streets, lanes, alleys, avenues and public places furnished shall be as follows:

- 11 - 2500 Lumen Aerial Lamps
- 28 - 4000 Lumen Aerial Lamps
- 15,000 Lumen Aerial Mercury Lamps

SECTION 3: That The Dayton Power and Light Company shall, at its own expense, furnish all lamps and other equipment necessary in and for the lighting of said streets and public ways, and construct, maintain and operate same, or where already erected, maintain same, and shall supply all electric energy necessary for the lighting of said lamps. The Power Company is to be paid by said Village for said lighting in twelve (12) equal monthly installments on or before the tenth day of each calendar month, subject, however, to the deductions for outages as herein provided, and the Power Company agrees that any additional lamps of the character aforesaid for the street lighting, ordered by said Council, shall be erected and operated by it at the same price per lamp as that above named, the same to be paid by said Village in the same manner and installments and at the times hereinbefore provided for said payments.

SECTION 4: That the location of every lamp shall be approved by the Lighting Committee of the Council of said Village before the lamps are erected, and after a lamp has been erected in accordance with such approval, the Power Company, upon a written order from the Council, shall remove it to another location, the cost of such removal and relocation to be paid by the Village of Centerville, Ohio.

SECTION 5: That said lighting shall be according to what is known as the "ALL NIGHT AND EVERY NIGHT SCHEDULE"; i.e., the lamps shall be illuminated every night from approximately one-half hour after sunset of one day to approximately one-half hour before sunrise of the next day, in accordance with which schedule each lamp shall be illuminated for approximately 4000 hours per year.

SECTION 6: That the Power Company shall use all diligence and care necessary to keep all the lamps clean and burning during the hours called for in this ordinance, and shall agree that if any light or lights go out, the lamps shall be repaired the same night if possible, and, in that event, no deduction for outage will be made; however, if any lamp or lamps are found to be still out on the second night, then the Village will make a deduction equal to two nights for each lamp not burning on the second night, and a deduction for each additional night that any such lamp is not burning, and these deductions shall be at the same ratio per night as the total monthly price bears to the time the lamp or lamps have been found to be out. The Village, through its Police Department, shall promptly report to the office of the Power Company all lamps discovered not burning.

SECTION 7: That whenever any tree or trees upon any sidewalk of any street, lane, alley or avenue shall seriously interfere with the distribution of light from any lamp or groups of lamps, of which the Council of the Village shall be the judge, the Village will trim, or cause to be trimmed, any such tree or trees in such a manner that such interference with the distribution of light will be removed.

SECTION 8: That the plans and specifications herein referred to for such street lighting, and on file with the Clerk of said Village, be and the same hereby are adopted and approved.

SECTION 9: That upon The Dayton Power and Light Company filing its written acceptance of this ordinance with the Clerk of said Village within thirty (30) days from the taking effect thereof, this ordinance shall be and constitute a contract between the Village of Centerville, Ohio and said The Dayton Power and Light Company to light the streets, lanes, alleys and public grounds, in accordance herewith, for a period of five (5) years, commencing on the 28th day of December, 1954.

SECTION 10: That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

SPECIFICATIONS FOR LIGHTING THE PUBLIC GROUNDS,
STREETS, LANES, ALLEYS AND AVENUES WITH ELECTRIC
LIGHT IN THE VILLAGE OF CENTERVILLE, STATE OF OHIO.

FIRST. The Lighting of the streets, lanes, alleys, avenues, and public places in the Village of Centerville, Ohio, shall be for a period of five (5) years, commencing on the 28th day of December, 1954.

SECOND. The minimum number of lamps of the various nominal lumen intensity to be used for the lighting of said streets, lanes, alleys, avenues and public places furnished shall be as follows:

- 11 - 2,500 Lumen Aerial Lamps
- 28 - 4,000 Lumen Aerial Lamps
- 15,000 Lumen Aerial Mercury Lamps

said lamps to be located as shall be directed by the Lighting Committee of the Council of the Village of Centerville, Ohio.

Each 2500 lumen aerial lamp shall be equipped with an open type metal reflector, or one equally as effective, for distributing the light in a horizontal direction.

Each 4000 lumen aerial lamp shall be equipped with a pendent type unit, Form 101 G.E., or something similar thereto, for directing and distributing the light on the street.

Each 15,000 lumen aerial mercury lamp shall be equipped with a type unit, Form 109, General Electric, or something similar thereto, for directing and distributing the light onto the street.

The lamps provided for in these specifications shall burn from approximately one-half hour after sunset until approximately one-half hour before sunrise on each and every night. This provides for approximately 4,000 hours' operation of each lamp per year.

THIRD. The Contractor, at its own expense and cost, shall furnish and erect poles, posts, wires, and other fixtures necessary to do said lighting and supply the lamps and renewals therefor, and do all that is required in connection with the lighting, all of which shall be erected in accordance with the plan for street lighting on file with the Clerk of said Village, which plan will be attached to the ordinance-contract for such lighting.

FOURTH. The Contractor shall, in the future, erect, maintain and light as aforesaid any additional lamps of the character aforesaid which the Council may order, and shall be paid therefor the same price and in the same manner as the original order for lamps.

FIFTH. The Contractor shall agree to use all diligence and care necessary to keep all the lamps burning during the hours called for in the ordinance to be executed, and shall agree that if any light or lights go out, the lamps shall be repaired the same night if possible, and, in that event, no deduction for outage will be made; however, if any lamp or lamps are found to be still out on the second night, then the Village will make a deduction equal to two for each lamp not burning on the second night, and these deductions shall be at the same ratio per night as the total monthly price bears to the time the lamp or lamps have been found to be out.

SIXTH. The map herewith attached shows the approximate location of the lamps intended to be covered by ordinance-contract for such lighting of the Village of Centerville, Ohio, and under these specifications.

SEVENTH. The Village shall, on or before the tenth day of each month, pay the Contractor for the lighting done during the next preceding month, subject to the deductions for outages provided for in these specifications.

ORDINANCE NUMBER 10-1954

VILLAGE OF CENTERVILLE

AN ORDINANCE TO FIX THE SALARY OF THE VILLAGE MARSHAL.

BE IT ORDAINED by the Council of the Village of Centerville, State of Ohio:

Section 1. That the salary of the Village Marshal shall be Four Thousand Two Hundred Dollars (\$4,200.00) per annum payable monthly.

Section 2. That the duly appointed Village Marshal shall furnish a fidelity bond for the sum of One Thousand Dollars (\$1,000.00) given by a corporate surety acceptable to the Council.

Section 3. That all ordinances or parts of ordinances inconsistent herewith shall be repealed, and this ordinance take effect from and after the first (1st) day of January, 1955.
