ORDINANCE NO. 2 - 1950

AN ORDINANCE FIXING THE PRICE WHICH THE DAYTON POWER AND LIGHT COMPANY, ITS SUCCESSORS AND ASSIGNS, MAY CHARGE FOR ELECTRIC LIGHT FURNISHED TO THE PUBLIC GROUNDS, STREETS, LANES, ALLEYS AND AVENUES IN THE VILLAGE OF CENTERVILLE, STATE OF OHIO, FOR A PERIOD OF FIVE (5) YEARS, COMMENCING ON THE 28TH DAY OF DECEMBER, 1949, AND DETERMINING THE MANNER IN WHICH SAID LIGHTING MAY BE FURNISHED, PROVIDED AND PAID FOR.

WHEREAS, there is on file with the Clerk of said Village of Center-ville, Ohio, complete plans and specifications for the lighting of the streets and public places of the Village with electricity, which plans and specifications provided for different type and rating of lights in different locations according to the local requirements, the lights being designated by candlepower and classified as hereinafter set forth.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, STATE OF

OHIO:

Section 1: That for a period of five (5) years from the 28th day of December, 1949, the price which may be charged by The Dayton Power and Light Company for electric light furnished to the Village of Centerville, Ohio, to light the streets, lanes, alleys, avenues and public places thereof in the manner and by the means set forth in the plans and specifications therefor on file with the Clerk of said Village, and as provided in this ordinance, shall be as follows:

100 Candlepower Lamps
For light supplied by means of one hundred (100)
Candlepower Lamps when the number thereof is

15, or less, the price shall be \$28.00 per lamp, per year, 16 to 30, the price shall be \$25.00 per lamp, per year, 31 to 60, the price shall be \$23.00 per lamp, per year, For all over 60, the price shall be \$22.00 per lamp, per year;

250 Candlepower Lamps
For light supplied by means of two hundred and fifty (250)
Candlepower Lamps when the number thereof is

15, or less, the price shall be \$36.00 per lamp, per year, 16 to 30, the price shall be \$33.00 per lamp, per year, 31 to 60, the price shall be \$30.00 per lamp, per year, For all over 60, the price shall be \$29.00 per lamp, per year;

For light supplied by means of 400 Candlepower Lamps, the price shall be \$40.00 per lamp, per year;

and said Power Company shall, at its own expense, furnish said lamps and equipment and material necessary for said lighting, and erect and maintain same, or where already erected, maintain same, and shall supply said lamps with the necessary electric current, and the Power Company is to be paid by said Village for said lighting in twelve (12) equal monthly installments on or before the tenth day of each calendar month, subject, however, to the deductions for outages as herein provided, and the Power Company agrees that any additional lamps of the character aforesaid for the street lighting ordered by said Council shall be erected and operated by it at the same price per lamp as that above named, the same to be paid by said Village in the same manner and installments and at the times hereinbefore provided for said payments.

Section 2: That the minimum number of lamps of the various candlepower to be used for the lighting of said streets, lanes, alleys, avenues and public places furnished shall be as follows:

said lamps to be located as shall be directed by the Lighting Committee of the Council of said Village of Centerville, Ohio.

Section 3: That said electric light shall be furnished by means of aerial construction only, and said Power Company shall be privileged to and shall install all necessary wires, poles, anchors, guys and all other equipment necessary and proper to accomplish such lighting by such means.

Section 4: That said lighting shall be according to what is known as the "ALL NIGHT AND EVERY NIGHT SCHEDULE"; i.e., the lamps shall be illuminated every night from approximately one-half hour after sunset of one day to approximately one-half hour before sunrise of the next day, in accordance with which schedule each lamp shall be illuminated for approximately 4,000 hours per year.

Section 5: That the location of every lamp shall be approved by the Lighting Committee of the Council of said Village before the lamp is erected, and after a lamp has been erected in accordance with such approval, the Power Company, upon a written order from the Council, will remove it to another location, the cost of such removal and relocation to be paid by the Village of Centerville, Ohio.

Section 6: That the Power Company shall use all diligence and care necessary to keep all the lamps clean and burning during the hours called for in this ordinance and shall agree that if any light or lights go out, the lamps shall be repaired the same night, if possible, and, in that event, no deduction for outage will be made; however, if any lamp or lamps are found to be still out on the second night, then the Village will make a deduction equal to two nights for each lamp not burning on the second night, and a deduction for each additional night that any such lamp is not burning, and these deductions shall be at the same ratio per night as the total monthly price bears to the time the lamp or lamps have been found to be out. The Village, through its Marshal, shall promptly report to the office of the Power Company all lamps discovered not burning.

Section 7: That whenever any tree or trees upon any sidewalk of any street, lane, alley or avenue shall seriously interfere with the distribution of light from any lamp or group of lamps, of which the Council of the Village shall be the judge, the Village will trim or cause to be trimmed any such tree or trees in such manner that such interference with the distribution of light will be removed.

Section 8: That the plans and specifications herein referred to for such street lighting and on file with the Clerk of said Village be and the same hereby are adopted and approved.

Section 9: That upon The Dayton Power and Light Company filing its written acceptance of this ordinance with the Clerk of said Village within thirty (30) days from the taking effect hereof, this ordinance shall be and constitute a contract between said Village and said Power Company to light the streets, lanes, alleys, avenues and public grounds, in accordance herewith, for five (5) years from the 28th day of December, 1949.

Section 10: That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

SPECIFICATIONS FOR LIGHTING THE PUBLIC GROUNDS, LANES, ALLEYS AND AVENUES WITH ELECTRIC LIGHT IN THE VILLAGE OF CENTERVILLE, STATE OF OHIO.

FIRST. The lighting of the streets, lanes, alleys, avenues and public places in the Village of Centerville, Ohio, shall be for a period of five (5) years, commencing on the 28th day of December, 1949.

SECOND. The street lighting shall be done by means of not less than -

- 100 Candlepower Series Mazda C Incandescent Lamps - 250 Candlepower Series Mazda C Incandescent Lamps - 400 Candlepower Series Mazda C Incandescent Lamps

Each 100 C.P. and 250 C.P. lamp shall be equipped with a metal reflector of the radial wave type, or one equally as effective, for distributing the light in a horizontal direction.

Each 400 C.P. lamp shall be equipped with a refractor globe and a reflector of suitable type for directing the light in the proper direction on the street on which said lamp is erected.

The lamps provided for in these specifications shall burn from approximately one-half hour after sunset until approximately one-half hour before sunrise on each and every night. This provides for approximately 4,000 hours' operation of each lamp per year.

THIRD. The lighting shall be furnished by means of aerial construction, and the Contractor shall, at its own cost and expense, erect poles, posts, wires and other fixtures necessary to do said lighting and supply the lamps and renewals therefor, and do all that is required in connection with said lighting. The lamps shall be supported upon posts or cross suspension wires, all of which shall be erected in accordance with the plan for street lighting on file with the Clerk of said Village, which plan will be attached to the ordinance-contract for such lighting.

FOURTH. The Contractor in the future shall erect, maintain and light as aforesaid any additional lamps of the character aforesaid which the Council may order, and shall be paid therefor the same price and in the same manner as the original order for lamps.

FIFTH. The Contractor shall agree to use all diligence and care necessary to keep all the lamps burning during the hours called for in the ordinance to be executed, and shall agree that if any light or lights go out, the lamps shall be repaired the same night, if possible, and in that event, no deduction for outage will be made; however, if any lamp or lamps are found to be still out on the second night, then the Village will make a deduction equal to two nights for each lamp not burning on the second night, and these deductions shall be at the same ratio per night as the total monthly price bears to the time the lamp or lamps have been found to be out.

SIXTH. The map herewith attached shows the approximate location of the Series Type C Incandescent Lamps intended to be covered by ordinance-contract for such lighting of the Village of Centerville, Ohio, and under these specifications.

SEVENTH. The Village shall, on or before the tenth day of each month, pay the Contractor for the lighting done during the next preceding month, subject to the deductions for outages provided for in these specifications.
