

ORDINANCE NO. 2 - 1949

It is hereby provided that, beginning with the 1st day of April, 1949, the rates charged for water furnished by the Village of Centerville to the residents of the Village of Centerville shall be as follows:

Five Dollars (\$5.00) for the first 7,500 gallons or any part thereof used per quarter

Thirty-Five Cents (\$.35) for each additional thousand gallons used during said quarter.

The rates for users outside the corporate limits of the Village of Centerville shall be the same as those charged residents in the Village of Centerville, except that an additional charge of Twenty-Five per cent (25%) of the rates prevailing under this Ordinance in said Village shall be added, to be paid by users outside the corporate limits of said Village of Centerville.

ORDINANCE NO. 1 - 1950

ANNUAL APPROPRIATION ORDINANCE
(Village)

An Ordinance to make Appropriations for Current Expenses and other Expenditures of the Village of Centerville, State of Ohio, during the fiscal year ending December 31st, 1950.

Section 1. Be It Ordained by the Council of the Village of Centerville, State of Ohio, That, to provide for the current expenses and other expenditures of the said Village of Centerville during the fiscal year ending December 31st, 1950, the following sums be and they are hereby set aside and appropriated as follows, viz:

Section 2. That there be appropriated from the GENERAL FUND:

That there be transferred from the GENERAL FUND to the SAFETY FUND the sum of \$3,880.00 (if revenues from sources other than taxes are to be deposited in the Safety, Service, etc., Funds as heretofore, an Ordinance to this effect must be passed by Council, Sec. 5625-11 G.C.); and that there be appropriated from said SAFETY FUND the following:
