ORDINANCE NO. 6 - 1945

AN ORDINANCE REGULATING THE PARKING OF VEHICLES IN THE VILLAGE OF CENTERVILLE

BE IT ORDAINED by the Council of the Village of Centerville, County of Montgomery and State of Ohio, three-fourths of the members elected thereto concurring:

<u>Section 1.</u> All motor driven vehicles parked on the public streets of Centerville must park parallel to the curb. Those vehicles headed in a northerly direction must park on the east side of the street; those vehicles headed in a southerly direction must park on the west side of the street; those vehicles headed in an easterly direction must park on the south side of the street; and those vehicles headed in a westerly direction must park on the north side of the street.

<u>Section 2.</u> For the safety of persons and property, all street signs, traffic light and other notices must be strictly obeyed.

Section 3. Any person found guilty of violating the provisions of this Ordinance shall be fined Five Dollars (\$5.00) or such lesser amount as shall be fixed by the Court.
