ORDINANCE NO. 7 - 1944

AN ORDINANCE TO AUTHORIZE THE PURCHASE OF WATER LINES AND TO APPRO-PRIATE MONEY THEREFOR.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, OHIO:

Section 1. That the Board of Trustees of Public Affairs be and they are hereby authorized to enter into a contract with and to purchase from the Annae B. B. Gorman Foundation the water lines which it owns consisting of the water lines and fire hydrant in Ridgeway Road, the line which extends along or near the property line between the premises owned by Leo Will and Wilhelmena Will (lot #3) and that owned by Elmer Tingle (lot #2) the line which extends along or near the property line between the premises owned by Blanche B. Kramer (lot #83) and the premises owned by Nelle L. Edelein (lot #82) and thence along or near the line between lots 84 and 85 owned by Frank McGurk, together with any laterals thereto or any other water lines for the sum of \$1500.00, payable in cash upon the completion of certain street improvements by said Foundation as the same shall appear in a contract between said Foundation and the Village.

Section 2. The sum of \$1500.00 is hereby appropriated out of the Water Department Fund for the purposes stated in Section 1 hereof.

Section 3. This ordinance shall be in full force and effect from and after the earliest date allowed by law.

> ORDINANCE NO. 8 - 1944 TO AUTHORIZE A CONTRACT WITH THE ANNAE B. B. GORMAN FOUNDATION.

WHEREAS, the Annae B. B. Gorman Foundation is the owner of certain lands in the corporate limits of the Village of Centerville, Ohio, being part of Section 25, Town 2, Range 6 MRs, which it is selling for residence purposes and on which it has laid out and dedicated Ridgeway Road and Hampton Road and proposes to lay out and dedicate parts of Davis Road and Lyons Drive, as public streets, but has not completed the work of draining and improving said streets and has agreed so to do; and

WHEREAS, said Foundation has constructed certain water lines in Ridgeway Road and other lines which are connected with the distribution system of the Village Water Works, which lines it is willing to sell to the Village to become a part of the distribution system of the Village of Centerville for the sum of \$1500.00; and

WHEREAS, it is desirable that the terminus of the water line on Ridgeway be connected with the water line on Cross Street, by way of Hampton Road, and the Village proposes so to do; and

WHEREAS, as yet Council has not accepted the plats dedicating Ridgeway Road, Hampton Road, Davis Road and Lyons Drive but proposes so to do upon completion of the draining and improvement of said streets by said Foundation in accord with plans and specifications therefor prepared or to be prepared by said Village,

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, OHIO:

Section 1. That the Board of Trustees of Public Affairs and the Mayor and Clerk be and they are hereby authorized to enter into a contract for and on behalf of the Village of Centerville with the Annae B. B. Gorman Foundation to carry into effect the objects and purposes above set forth.

<u>Section 2.</u> This ordinance shall be in full force and effect on and after the earliest date allowed by law.

ORDINANCE NO. 11 - 1944

AN ORDINANCE FIXING THE PRICE WHICH THE DAYTON POWER AND LIGHT COM-PANY MAY CHARGE FOR ELECTRIC LIGHT FURNISHED TO THE PUBLIC GROUNDS, STREETS, LANES, ALLEYS AND AVENUES IN THE VILLAGE OF CENTERVILLE, OHIO, FOR A PERIOD OF FIVE (5) YEARS, COMMENCING ON THE 28th DAY OF DECEMBER, 1944, AND DETERMINING THE MANNER IN WHICH SAID LIGHTING MAY BE FURNISHED, PROVIDED AND PAID FOR.

WHEREAS, there is on file with the Clerk of said Village complete plans and specifications for the lighting of the streets and public places of the Village with electricity, which plans and specifications provide for different type and rating of lights in different locations according to the local requirements, the lights being designated by candle-power and classified as hereinafter set forth.
BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, STATE OF OHIO:
<u>Section 1.</u> That for a period of five (5) years from the 28th day of December, 1944, the price which may be charged by The Dayton Power and Light Company for electric
