AN ORDINANCE REGULATING BLASTING OPERATIONS WITHIN THE VILLAGE OF CENTERVILLE.

BE IT ORDAINED by the Council of the Village of Centerville, in the County of Montgomery and State of Ohio, three-fourths of the members elected thereto concurring:

Section 1. It shall be unlawful to carry on blasting operations within the Village of Centerville unless such operations are so securely and appropriately covered as will completely protect the person and property of all others lawfully within the said Village from Vibration and flying earth, stone, or other materials and substances.

Section 2. Whoever violates any of the provisions of this ordinance shall upon conviction there-of be fined not less than (\$50.00) fifty dollars and not more than (\$500.00) five-hundred dollars, for each offense.

Section 3. This ordinance shall take effect and be inforce from and after the earliest period allowed by law.
