Lulla Grown ORDINANCE NO. 7 - 1940 An Ordinance forbidding the shooting of guns or pistols within the corporate limits of the Village of Centerville and declaring an emergency. BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, in the County of Montgomery and State of Ohio, three-fourths of the members elected thereto concurring: Sec. 1. Whoever shoots or fires a gun or pistol at any stationary or moving object tor thing, at a bird, fowl, animal or other living thing, within the corporate limits of the Village of Centerville shall be fined not less than Five (\$5.00) Dollars nor more than Fifty (\$50.00) Dollars: Provided, however, that the provisions of this ordinance shall not apply to regularly ap ointed or elected state, county, township or municipal police officers acting in the line of duty. Provided, further, that the provisions of this ordinance shall not apply to persons, who are in good faith protecting themselves or others from mad, infuriated or otherwise dangerous animals. Sec. 2. That this ordinance is declared to be an emergency measure for the reason that the public peace, health and safety of the Village of Centerville require the forbidding of the shooting of guns or pistols within the corporate limits of the said village immediately. That this ordinance shall take effect immediately upon its passage. Sec. 3. Passed this 10thday of June, 1940. Approved: Attest: Emory W. AN ORDINANCE ESTABLISHING THE GRADE OF EAST AVENUE FROM WELLER AVENUE SOUTH TO MARTHA AVENUE AND OF MARTHA AVENUE FROM EAST AVENUE WEST TO MAIN STREET, AND DECLARING AN EMERGENCY. BE IT ORDAINED BY the Council of the Village of Centerville, in the County of Montgomery and State of Ohio, three-fourths of the members elected thereto concurring: That the grade of East Avenue from Weller Avenue south to Martha Avenue be and the same Sec. 1. is here by established, as follows: Using the United States Coastal and Geodetic Bench Mark, a square chisled in the top of concrete curb at the southeast corner of Main and Franklin Streets, which elevation is 1020.30 feet above sea level: beginning at the intersection of the center lines of Weller Avenue and East Avenue, Elevation 991.10 feet, thence continuing southwardly with the center line of East Avenue and with a crown grade of 1.25% for a distance of 410 feet, thence continuing southwardly with the East Avenue and with a crown grade of 2.5% That the grade of Martha Avenue from East Avenue west to Main Street be and the same hereby is established, as follows: Beginning at the intersection of East Avenue and Martha Avenue with an elevation of 982 Pet feet thence westwardly with the center line of Martha Avenue and with a crown grade of 1.25% for a distance of 200 feet, thence westwardly with the center line of Martha Avenue and with a crown grade of .5% for a distance of 400 feet, thence continuing westwardly with the center line of Martha Avenue and with a crown grade of 4 07% for a distance of 330 feet to the established grade at the center line of Main Street. That this ordinance is declared to be an emergency measure for the reason that the public peace, health and safety of the Village of Centerville require the immediate establishment of the grade of said streets between the points aforesaid in order to proceed with the improvements contemplated and shall take effect upon its passage.
