- sec(1) It shall be unlawful for any person, or persons within the limits of said Village to suffer any Privy, Stable, Hog Pen or any premises to become offensive to any other inhabitant of said Village.
- sec(2) Any such person violating sec. 1 of this Ordinance shall upon complaint of any person state such n uisance within five days from date of complaint.
- Sec(3) Any person, or person neglecting to abate said nuisance within five days from date of complaint shall upon conviction be fined not more than ten dollars, and costs and be confined in prison until said fine and costs are paid, or secured to be paid or otherwise dis charged according to Law.
