# **PUBLIC HEARINGS**

# Application P-2020-0005: Conditional Use Request Cynthia Whitaker, Thia Pets Grooming, 871 East Franklin Street

Mr. Yandrick presented the staff report on a conditional use application for Cynthia Whitaker of Thia Pets Grooming. The request is to have a dog grooming business at 871 E. Franklin Street. The Unified Development Ordinance requires a Conditional Use approval for a dog grooming (kennel) business in a B-2 zoning district. Mr. Yandrick stated dog grooming for more than 4 dogs is listed as a kennel in definitions of the Unified Development Ordinance and are only

permitted in the B-2 Zoning district with a Conditional Use Approval. He pointed out prior to being located in Washington Township this was an at home business in Centerville. Mr. Yandrick reviewed the standards of approval, before stating the application met the criteria and recommending approval of the conditional use application.

Mr. Von Handorf opened the public hearing.

Cynthia Whitaker, owner of Thia Pets Grooming indicated she was available to answer any questions commissioners may have. Mr. Yandrick indicated he received an anonymous phone call in opposition of the application and also received an email from a business across the street in support of the application.

Mrs. Davis reported no pending citizen requests to comment via email nor the Raise Your Hand option available through the Zoom.com platform.

Mr. Von Handorf closed the public hearing.

MOTION: Mr. Durham made a motion to recommend to Council the approval of Conditional Use Application P-2020-0005. Ms. Korenyi-Both seconded the motion. The motion passed with a 6-0 roll call vote.
