AN ORDINANCE AUTHORIZING THE WRITE-OFF OF THE UNCOLLECTIBLE ACCOUNTS FOR WASTE COLLECTIONS

WHEREAS, the City of Centerville provides for garbage and rubbish collection within the City as set forth in Chapter 1060 of the Centerville Municipal Code; and

WHEREAS, Centerville Code Section 1060.05 sets forth the process and procedure for the collection of fees for said waste collection; and

WHEREAS, diligent efforts are made to collect on delinquent accounts; and

WHEREAS, upon failure of a property owner to pay said fees, such fees may be assessed against the property owner's real estate taxes; and

WHEREAS, the City is in the process of converting its utility billing system; and

WHEREAS, it is desirable for the City to clean up old balances and make a determination of said balances which have been deemed uncollectible either because the individuals either no longer own the property or are deceased; and

WHEREAS, it has been determined that these accounts can no longer be sent to the County Auditor's office due to the fact that the individuals no longer own the property; and

WHEREAS, the write-off of uncollectible accounts is necessary to provide an accurate measure of the City's financial position and to avoid transferring those uncollectible balances to the new system; and

WHEREAS, attached to this Ordinance is a listing of uncollectible accounts; and

WHEREAS, it is fiscally responsible to write-off delinquent accounts that are deemed uncollectible.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. City Council hereby agrees and acknowledges that it is in the best interests of the City to write-off uncollectible accounts.

Section 2. The City Council recognizes that the accounts listed on the attachment to this Ordinance are uncollectible.

Section 3. City Council hereby authorizes the write-off of the uncollectible accounts for waste billings as set forth in the attachment.

Section 4. This ordinance shall be effective from and after the earliest date allowed by law.
