A RESOLUTION AUTHORIZING THE COVID-19 BUSINESS RELIEF PROGRAM FOR THE CITY OF CENTERVILLE.

WHEREAS, on March 13, 2020, President Donald Trump declared a National Emergency concerning the Novel Coronavirus Disease (COVID-19) outbreak; and

WHEREAS, in Executive Order 2020-01D, Ohio Governor Mike DeWine declared a state of emergency for the entire State to protect the well-being of the citizens of Ohio from the dangerous effects of COVID-19 and to assist in protecting the lives, safety, and health of the citizens of Ohio; and

WHEREAS, the City of Centerville has declared a State of Emergency related to COVID-19; and

WHEREAS, the City desires to assist businesses in the City to address the negative financial effects of the COVID-19 pandemic with a program intended to help with expenses directly resulting from business interruption or arising from the decrease in gross revenue in connection with the COVID-19 pandemic; and

WHEREAS, the State adopted HB 481, which made funds available for small business programs through the Coronavirus Relief Distribution Fund; and

WHEREAS, the City has a relationship with the Centerville Community Improvement Corporation (CCIC), which administers grant programs for the City.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. The City Council hereby directs City Staff to create a grant program for City businesses that are impacted by COVID-19, to be funded by the HB 481 Coronavirus Relief Distribution Fund and administered by the Centerville Community Improvement Corporation.

Section 2. Attached hereto and incorporated herein are the terms and conditions for the program.

Section 3. This Resolution is to take effect at the earliest date allowed by law.
